**TERMS OF APPLICATION FOR MEMBERSHIP**  
**2012 - 2013**

1. I (we) agree to pay a \$75 registration fee and a \$200 commitment fee in consideration for participation in the MHA 2012 – 2013 season tryouts. Players wishing to decline placement will be given ample time to do so. **The commitment fee will be refunded only if a player declines his/her placement as required by the date specified; otherwise, the commitment fee is non-refundable.** If the player is not placed on a team the \$200 commitment fee will be returned. Registration fee is non-refundable.
2. I (we) agree to pay all fees as listed in the 2012 – 2013 fee schedules below and acknowledge that all fees paid are non-refundable. If a player voluntarily withdraws from the MHA for any reason fees paid on behalf of the player are forfeited and player is not relieved of any unpaid fees.
3. I (we) agree that if placed on a team, I am financially responsible for the purchase of 2 MHA game jerseys, 2 sets of socks (1-home, 1-away), and a practice jersey. Varsity players must also purchase 2 sets of shells. I agree that I am also responsible for return and or replacement and repair of any equipment that may be assigned to my child, which is lost, stolen or damaged beyond reasonable use in the field of play.
4. Offer of Membership: By signing this document you agree and understand:
  - a. That membership to the MHA is conditional upon an offer of membership extended by the organization. Said offer is discretionary and solely the responsibility of the MHA Board of Directors, regardless of the skill level of your player and said Membership can be denied for any reason by said board.
  - b. That the player is selected during the normal evaluation process and is offered a position on a team.
  - c. That you accept and adopt all USA Hockey, MidAM, PIHL, and MHA, rules and regulations.
  - d. That both the parents/guardians and player will abide by all USA Hockey, MidAm, PIHL, and MHA policies, rules and regulations, including, but not limited to those referenced within the MHA Player / Parent Handbook, as well as satisfy all financial obligations.
5. I understand that signing this agreement does not guarantee my child a position in the MHA or on any MHA team. Registration fees will not be refunded should your child be selected for a team and decide to voluntarily withdraw after selection has been made.
6. In consideration of my participation and / or the participation of my child in the tryouts and /or regular season program, I (we) knowingly assume all risks and hazards thereof, including, but not limited to those known and / or unknown, foreseen and / or unforeseen. Further, I agree to release, defend, absolve, indemnify, and hold harmless the Montour School District, Pennsylvania Interscholastic Hockey League (PIHL), Montour Hockey Association (MHA), its Directors, Officers, Coaches, Officials, and their agents, servants and all other representatives and members as well as USA hockey, Inc. from any and all liability, loss, expense, attorney's fees and claims for injury, death or damage which in anyway relate and / or refer to participation in the program.

- If you have 2 or more players in the organization you qualify for a sibling discount of \$200. Deduct the \$200 from the combined fees stated above.
- After the final date to decline placement the Commitment Fee and all subsequent Fees paid are NON-REFUNDABLE.
- Voluntary withdrawal from the Montour Hockey Association by a player for any reason will result in the forfeiture of all fees paid on behalf of that player and player is not relieved of any financial obligation.
- Fees and Other Credits are non-transferable between players.
- In order for the organization to operate efficiently prompt payments are expected. Any player not current on payment by August 31, 2012 will not be permitted to participate in practice, scrimmage, or tournaments.
- Mandatory fundraisers will be held throughout the year, and participation is required. Players who do not participate in the mandatory fundraisers will be invoiced for the required amount of the fundraiser.
- All checks received unpaid for reason will be charged a fee of \$25.00.
