TERMS & CONDITIONS

Sealed tenders are invited in two bid systems i.e. (i) Technical Bid and (ii) Financial Bid from the manufacturing firms or authorized distributors for the purchase of Fluorescent Jackets for use in Delhi Police and approved sample kept in CSA Clothing Store/P&L. The tender can be sent through Registered Post, Speed Post, through Courier or these can be put personally in the sealed tender box kept at Reception/Provisioning & Logistics located at 5, Rajpur Road, Delhi – 110054 by 11.00 AM on 02.05.2013. Tender received after stipulated date & time shall not be accepted and no request will be entertained on any ground/reason:-

Bidders are advised to quote their rates after carefully study of the following terms and conditions of the tender:-

- 1. Separate envelope should be used for TECHNICAL BID as well as for FINANCIAL BID. The word "TECHINICAL BID/FINANICAL BID for the purchase of Fluorescent Jackets due to reach **by 11.00 AM on 02.05.2013** shall be prominently marked on the top of each envelope and both the sealed envelopes (Technical Bid and Financial Bid) should further be put in a bigger envelope duly sealed and super scribed.
- 2. The tenders should reach this office by 11.00 AM on 02.05.2013. Tender received after stipulated date & time shall not be accepted and no request will be entertained on any ground/reason:-
- 3. The TECHNICAL BIDS will be opened first at <u>12.00 Noon on 02.05.2013</u> and the FINANCIAL BIDS of only technically approved company/firms will be opened only after scrutiny of technical bid and getting the samples tested from a laboratory.
- Only Sales Tax/VAT registered company/firm(s) are eligible to participate in this tender. The valid Sales Tax/VAT Registration Certificate must be attached with technical bid.
- 5. The latest Sales Tax/VAT Deposit acknowledgement/ challan must be attached with the technical bid.
- 6. Only manufacturing firms for garments and authorized distributors can participate in the tender. A certificate having a proof of manufacturer issued from DGS&D/NSIC/Min. of Industries/Defence etc. or authorized distributorship should be attached with the tender form. This is subject to verification, if necessary.
- 7. In case bidder is authorized distributor, authorized distributorship certificate of manufacturing firms for garments alongwith proof of manufacturer thereof, as stated at **SI. No.6** above, should be submitted.

- 8. HIGH GLOW RETROREFLECTIVE MATERIAL: Micro prismatic material of 50 mm and 90 mm wide Bands of new material conforming to EN 471-2003+AI:2007 shall be used on the Fluorescent Jackets.
- 9. The Retro Reflective Tape manufactured by reputed manufacturers viz. 3M-USA, Reflexite-USA/Ireland, Avery Dennison-USA and Reflomax-Korea should be used for fabricating Fluorescent Jacket.
- 10. Retro Reflective Tape shall be Micro prismatic type white colour certified by the manufacturer of retro reflective material.
- 11. A letter from the Tendering firm/company should be submitted indicating the name of original manufacturers of Retro Reflective Material, from whom they would be procuring the Tape for fabrication of Fluorescent Jackets.
- 12. A letter from the original manufacturer of Retro Reflective Material should be submitted certifying the following aspects:
 - a. That they are the original manufacturer of Retro Reflective Tape and that that they manufacture material conforming to specification No.EN 471-2003+AI:2007.
 - b. That they are authorizing the tendering firm to participate in the Tender for the Retro Reflective Tape supplied by them.
- 13. Test Certificate of Retro Reflective Tapes certified by the manufacturer or any International Laboratory certifying the Reflective Tape supplied to the tendering company/firm confirms to Specification No. EN 471-2003+AI :2007.
- 14. The Retro Reflective Material should be certified by the manufacturer to withstand 75 wash cycles @ 60 degree C.
- 15. The tendering company/firms have to submit THREE tender samples of Fluorescent Jackets as per tender specification alongwith the tender.
- 16. The words "DELHI POLICE" shall be screen printed with PVC transient glossy ink on Retro Reflective Tape in the front and back side, as shown in the sample displayed in CSA Clothing Store/P&L.
- 17. After evaluation of technical bid(s) of all the tendering firms, tender samples of those firms, which are declared technically qualified in the technical bid on the basis of documents and whose samples are found matching with the approved sample with respect to feel, finish, shade, design and pattern, will be sent for lab testing of the fabric. The testing charges shall be borne by the firm concerned.
- 18. The Financial Bids of only those companies/firms will be opened, whose sample fabric is found as per tendered specifications in the lab test report and matching with approved sample kept in CSA Clothing Store/P&L.
- 19. Approved samples of Fluorescent Jacket for feel, finish, shade, design and pattern can be seen at CSA Clothing Store/P&L between 10.00 A.M. to 5.00 P.M. on any working day before the closing of Tender Box.

- 20. The Fluorescent Jacket shall be legibly stamped with the manufacturer's name or his recognized trademark.
- 21. Fluorescent Jackets are required in four sizes i.e. Small, Medium, Large and Extra Large.
- 22. The following test certificates will be submitted by the successful bidder at the time of supply of stores:-
 - (a) Test Certificate of Retro Reflective Tape certified by the manufacturer or any International Laboratory certifying that the Reflective Tape confirms to EN 471-2003+AI:2007. The same should be capable to co-relate beyond doubt with the imported material used in Fluorescent Jacket. Tester Certificate should specifically mention about the batch/Lot number and manufacturers marking on it.
 - (b) Purchase/ Import document co-relating the Retro Reflective Tape used in fabrication of Fluorescent Jackets.
 - (c) The retro reflective material should be certified by the manufacturer to withstand 75 wash cycles @ 60 degree C.
- 23. The Samples of previous tender shall not be considered.
- 24. The tendering company/firm have to submit an undertaking that colour and shade of bulk supply will be similar to the approved sample displayed/available in CSA Clothing Store/P&L.
- 25. The person signing the tender documents should be authorized for signing the tender documents and his signature should be attested by owner/partner/director of the tendering company/firm. A certificate in this regard, duly issued by the Director/owner/partner, must be attached alongwith tender documents.
- 26. Only authorized representative will be allowed to attend the meeting of the Purchase Committee. He/She should also bring authority letter on company/firm's letter head that any decision/negotiation taken by him/her would be accepted by company/firm.
- 27. No representative shall be allowed to attend the meeting of the Purchase Committee on behalf of more than one tendering company/firm. The representative, who is deputed to attend the meeting, should be Director or Partner or Owner or an employee of the company bearing an authority letter, whose specimen signatures should be attested by the company/firm's authorized signatory having seal of the company/firm.
- 28. A copy of terms and conditions duly signed by the bidder, as a token of acceptance of the same will be attached along with the tender.
- 29. The Purchase Committee or Purchaser, in order to satisfy itself can order an on the spot enquiry to verify the soundness, capability, viability and any other information given by the tendering company/firms. The documents submitted the bidders can be verified from the concerned authorities.

- 30. The Account Payee demand Draft of **Rs.500/-** as tender fee in favour of "Deputy Commissioner of Police, Prov. & Logistics, 5-Rajpur Road, Delhi", be attached with the technical bid irrespective of registration status etc. of the firm. The application fee is non refundable. No tender will be accepted without tender fee and shall be rejected straightway.
- 31. The Earnest Money Deposit (EMD) of **Rs.1,20,000/-** shall be deposited by the bidders with the Technical bid, which can be submitted in the form of A/C Payee Demand Draft, FDR, Banker's Cheque or Bank Guarantee from any Commercial Bank in an acceptable form in favour of "Deputy Commissioner of Police, Prov. & Logistics, 5-Rajpur Road, Delhi". EMD deposited with the tender shall bear no interest. The EMD should be valid for a period of forty five days beyond the date of the bid validity from the date of expiry of tender. Earnest money shall be refunded to the unsuccessful bidders, after finalization of tender and award of work, to the successful bidder(s). No tender will be accepted without EMD and shall be rejected straightway.
- 32. The company/firms registered with NSIC/DGS&D for the particular item are exempted from depositing of EMD. The participating firm, who are exempted for depositing the EMD, shall deposit valid documents in support of exemption with the Technical bid. However, there shall be no exemption for requisite Application Fee to any participating firm irrespective of its registration status, etc.
- 33. The tendering company/firms will have to deposit an Account Payee Demand Draft amounting to Rs.15,000/- in favour of "Deputy Commissioner of Police, Provisioning & Logistics, Delhi" on account of lab test charges with the technical bid irrespective of registration status etc. of the firm. The amount for lab test charges is tentative. Actual charges will be intimated after receipt of bills for lab test charges and if lab test charges are higher, the excess amount will be paid by the tendering company/firm. The excess amount of lab test charges will be refunded to the tendering firm.
- 34. All the company/firms participating in the tender must attach a list of their Directors/Owners/Partners/Proprietor etc. with the technical bid.
- 35. All the company/firms participating in the tender must attach a certificate to the effect that the company/firm is neither blacklisted by any Govt. Deptt. nor any criminal case is registered/pending against the company/firm or its director/owner/ partner anywhere in India. The company/firm who is blacklisted by any Govt./Semi Govt. Deptt. or any criminal case is registered/pending against the company/firm or its Director/Owner/Partner/Proprietor anywhere in India is/are not eligible to participate in this tender.
- 36. The tender will be rejected straight way without assigning any reason, if the Proprietor, Partner(s), Director(s) or the firm/company found involved in any criminal case at any stage, declared blacklisted by any Govt./Semi Govt. department etc.
- 37. After evaluation of technical bid(s) of all the tendering company/firms, the tender samples of those company/firms, which are declared technically qualified in the technical bid on the basis of documents, will be sent for lab testing. The testing charges shall be borne by the company/firm concerned.

- 38. The Financial Bids of only those company/firms shall be opened, whose samples are found conforming the tender specifications in the lab test report.
- 39. The Financial Bid should be filled as per proforma enclosed as **Annexure B.**
- 40. The rates are to be quoted by the bidders inclusive of all taxes, levies, charges etc. in Indian currency and payment shall also be made to successful bidder (s) in Indian currency.
- 41. The price must be quoted inclusive of all taxes and Govt. levies, charges etc. Nothing over and above the quoted/accepted price will be payable by the purchaser.
- 42. The tendering company/firms shall clearly mention the Guarantee/Warranty of the tendered stores, which shall not be less than one year from the date of acceptance of store.
- 43. The rates will be valid for a period of six months from the date of opening of tender.
- 44. The rates will be F.O.R. at 5, Rajpur Road, Delhi 54.
- 45. The company/firm whose rates are accepted shall have to deposit 10% of the total contractual value as Performance Security (Security Money) in the shape of an Account Payee Demand Draft, Fixed Deposit Receipt, Bank Guarantee from a Commercial Bank in an acceptable form in favour of Deputy Commissioner of Police, Provisioning & Logistics, 5, Rajpur Road, Delhi 110054 before the supply order is placed to the company/firm. The Performance Security (Security Money) shall bear no interest. The Performance Security should be valid for 60 days beyond the completion of all contractual obligations by the supplier including the warranty/guarantee period.
- 46. In case the company/firm, whose rates are accepted, fails to deposit requisite Performance Security within the prescribed/reasonable period, the EMD deposited by the company/firm will be forfeited and firm will be blacklisted.
- 47. The quantity and sizes of the item(s) mentioned in the tender notice can be increased or decreased, at any stage till the delivery of consignment is completed.
- 48. The Purchase Committee will have discretion to award the contract to more than one company/firm, if their L-1 rates are found the same.
- 49. The supply of the stores will be made <u>within 90 days</u> from the receipt of supply order, on the basis of clearance from lab as per following schedule :
 - i) 4000 Nos. within 60 days.
 - ii) 3940 Nos. within next 30 days.
- 50. The department reserves the right to cancel the supply order or part supply thereof in case of the following contexts:
 - a. Failure of the company/firm to supply the stores as per time schedule prescribed in Clause No. 49.
 - b. If the supplied store is inferior to the samples approved/specified/lab tested.

- 51. In case of cancellation of the supply order as at Clause 50 above, the balance store can be procured from open market and the difference of cost, if any, will be recovered from the pending bill/Performance Security of the company/firm, besides forfeiture of the entire Performance Security and other punitive action like blacklisting of the company/firm will be taken.
- 52. The stores will be supplied as per delivery schedule prescribed in Clause No. 49 failing which liquidated damage charges will be claimed @ 0.5% of total cost of delayed quantity per week, which may be maximum upto the limit of 10% of delayed quantity cost. Besides, action can be taken to blacklist the company/firm and forfeiture of its Performance Security.
- 53. Force Majeure: The Contractor shall not be liable for forfeiture of its performance security, liquidated damages or termination for default, if the delay in performance or other failure to perform its obligations under the contract is a result of an event of Force Majeure. For purposes of the clause, "Force Majeure" means an event beyond the control of the Contractor and not involving the Contractor's fault or negligence and not foreseeable. Such events may include wars or revolutions, fires, floods, epidemics, quarantine restrictions, freight embargoes etc.
- 54. The Survey Committee can order to get one random sample, from each consignment received, tested from authorized and reputed lab and the testing charges will be borne by the company/firm. In case the supply is found inferior to tendered specification, the consignment will be rejected. The firm will have to take back the consignment at their own cost and replace it with fresh stock of correct specification within the specified period. In case the supplier fails to give or to replace the supply as per specification, the Performance Security will be forfeited, besides cancellation of the supply order and blacklisting of the company/firm. The un-acceptable stores shall be subject to replacement at the risk and responsibility of the bidder.
- 55. The unsuccessful bidders shall be responsible to collect the sample deposited by them with the tender within 15 days after the day of opening of financial bids. Thereafter, no claim to return the sample will be entertained by the Purchaser.
- 56. The Competent Authority reserves the right to reject/cancel/scrap any tender or all tenders without assigning any reasons thereof on the recommendation of the Purchase Committee/Purchaser.
- 57. Bidders shall not be permitted to alter or modify their bids after expiry of the deadline for receipt of bids.
- 58. The payment will be made on receipt/acceptance of store in good condition as per approved sample/specification. No advance payment will be made. No claim for interest, if the payment is delayed, will be entertained.
- 59. The payment will be made depending upon the availability/release of funds by the Govt. under appropriate head of accounts and the bidders shall have no claim of interest in case the payment is delayed, due to this or any administrative reasons.

- **60.** Detailed Specification of FLUORESCENT JACKET in details are enclosed with these terms and conditions at **Annexure A.**
- 61. The Competent Authority reserves the right to relax any terms and conditions in the Govt. interest on the recommendation of the Purchase Committee/Purchaser during the tender process.
- 62. In case of any differences arises between company/firm and department, the company/firm can be called for negotiation on table to patch-up the matter amicably prior to approaching court.
- 63. All procedure for the purchase of store laid down in GFR and DFPR shall be adhered-to strictly and the bidders are bound to respect the same.
- 64. In case any adverse report/information/complaint etc. before/after the opening of tender against the bidder(s) about any ring formation/pooling of tender, deceitful act, concealment of fact etc. is received/noticed, the EMD/Security Deposit of the firm(s) will be forfeited and the firm(s) will be blacklisted, besides strict legal action as per law will be taken separately.
- 65. Incomplete and conditional tender will not be accepted.
- 66. All disputes are subject to the jurisdiction of the Courts in the N.C.T. of Delhi.
- 67. In case, the bidder(s) violate/breach any of the terms & conditions of the tender or contract/supply order, an explanation of the company/firm can be called by issuing Show Cause Notice. If the reply of Show Cause Notice is not found satisfactory, strict legal action as per law will be taken, besides forfeiture of EMD/Security Deposit and blacklisting of firm.
