

Obama Throwing America Under Bus

At the NATO summit back in April, President Obama was asked if he subscribed to the "school of American exceptionalism that sees America as uniquely qualified to

lead the world."

"I believe in American exceptionalism, just as I suspect that the Brits believe in British exceptionalism and the Greeks believe in Greek exceptionalism," he answered.

For all of Obama's flip-flops, he has been insistent on the issue of American exceptionalism – or lack

thereof. Events over the last week have added to the evidence that Obama's America is one enslaved to multicultural postmodernism. It's been a bad November for American exceptionalism.

November 5. Remember, remember the fifth of November – the Jihadist treason and plot: U.S. Army Major Nidal Malik Hasan shouts "Allahu Akhbar!" as he kills 12 of his fellow service members, one contractor, and wounds 42 others in an attack on Ft. Hood. Obama cautions "against jumping to conclusions" about the religious motivations of Hasan's attack.

assume that what is good for us is automatically good for somebody else." He needn't worry. During this leg of the Asia trip, the Chinese government commented on how nations should be deficit neutral and have a stable monetary policy.

Obama's Weakness On Display Around The World

Health Care Gets Down To Who Do You Trust?

The topic of death panels was not too far away from the American psyche in the past couple of weeks and while many people can understand the concept intellectually it all boils down to a basic question:

Can you trust the government with your medical future?

The answer for a huge majority of America is, **NO**.

Intellectually, we know that we probably spend way too much money prolonging life when all hope is gone.

But the key question is who gets to decide at exactly what point all hope leaves the building?

And allowing any government entity to make those decisions is simply not acceptable to most people.

If you need any real evidence on that point, look at the pronouncement last week from a government sponsored panel which said that mammograms really weren't necessary for women in their 40s. The U.S. Preventive Services Task Force is one of those government entities whose recommendations carry a lot of weight—particularly with insurers—and it's fair to point out that this group was appointed during the Bush administration.

And, intellectually, what they said is correct. Because what they really said was not that women in their 40s don't need mammograms but rather that such mammograms only saved a relatively few women from breast cancer.

That certainly makes financial sense—unless the woman in question happens to be your wife.

You see, it's easy for a task force to look at cost-benefit relationships.

If there are two percent more women who die of late-diagnosed breast cancer, well, that's life. Right? After all, look at all the money we'd save.

Wrong.

The problem is that women (and men) who wear pink ribbons and participate in the Susan G. Komen events are worried about saving every life possible. And the task force is worried about saving money. Apples and Lugnuts.

care system—more than it already has—such task forces will set those protocols and there will be little or nothing which can be done. It's how government works.

You were expecting maybe Marcus Welby MD would make those decisions? Or Dr. Huxtable?

The problem with the hard left's promise to reform our health care system is they have no idea how to lower the costs.

The first question nobody has ever asked is why some of this stuff costs what it does?

We seem to have an inverse of the law of supply and demand.

If you put 15 CAT scanners in one town both the number of CAT scans AND the price seems to increase.

That's an indication that a) there is no free market in CAT scans because b) there is no incentive to lower the price. Why? Because the government has set an acceptable price it will reimburse and that sets a floor under all pricing.

What would happen if insurers put out such commodity procedures such as MRIs and CAT scans for bids and the low bidder got all the business?

The answer is that in mere days, billions would be saved.

This happens because the vast majority of Americans never even look at their medical bills. Just like they never get first count on their taxes due to with-holding.

If every American first had to write a check and then was reimbursed by their insurer, my guess is that the cost of most medical procedures would be reduced overnight. If every American actually had to write a check to the government on April 15, the same thing would happen to government.

If you want to reform our healthcare system, start with the source of the ever increasing costs. You'll get a lot farther than by merely re-arranging the deck chairs on the Titanic which is a pretty good description of Harry Reid's bill in the Senate.

Dollar Meltdown

The current investment climate is more perilous than ever. The Federal Reserve's balance sheet continues to grow stuffed with the dubious paper purchased from the too-big-to-fail banks that are now wards of the state. The music stopped and there were no chairs, but the Fed and the Treasury snapped their fingers and trillions of dollars later the chairs appeared, the band played on and the banks live on. The taxpayers are now the not-so-proud owners of AIG, General Motors, Fannie and Freddie and dozens of banks. Where did the money come from? Out of thin air.

Every paper currency in history eventually reaches its intrinsic value – zero – and the Fed's Ben Bernanke is doing all he can to see that the dollar becomes worthless sooner rather than later. As Marc Faber told an investment conference crowd recently, Zimbabwe's serial inflator Robert Mugabe is Bernanke's mentor.

Investors live in the here and now. We can't pick what our investment climate will be. If only we could live our lives with the market deciding what money is and 100-percent reserve banks protected our money on deposit. No such luck. The financial waters are treacherous and we must navigate them.

Charles Goyette provides a roadmap for survival with his newly released book, The Dollar Meltdown: Surviving The Impending Currency Crisis With Gold, Oil, And Other Unconventional Investments. The former Phoenix radio talk-show host has learned from some of the brightest minds in economics and investing. It's the rare book that engagingly teaches sound economic theory, provides the history of how we got in this mess and then provides solid investment advice that considers the precarious times we live in. As ambitious as this sounds Goyette's fast-paced book gets it all done.

The author brings the reader up to speed writing about the bailouts and the nation's debt. After explaining why gold has been the market's choice for money for thousands of years, he writes about every saver and investor's nightmare – inflation – using the modern example of Mugabe's Zimbabwe, a once prosperous nation reduced to a Stone Age economy with the continuous printing of paper money. Everyone is a billionaire but nobody can buy anything.

Goyette looks to Murray Rothbard to explain the history of America's Federal Reserve and fractional reserve banking, and to Ludwig von Mises to see what the crack-up boom might look like. He makes the poignant point that hyper-inflation is not just something engendered in banana republics. Israel experienced triple-digit price inflation in the late 1970s and early 1980s.

Every once in a while dissatisfaction with the dollar makes the news, most recently with super model Gisele Bündchen demanding to be paid in euros rather than dollars. But the Brazilian bombshell was not the first. Goyette writes that Bette Midler demanded gold Krugerrands to perform overseas in the 1970's. No doubt the Devine Miss M was influenced by then manager and boyfriend Aaron Russo.

Ultimately inflation leads to a state-controlled economy and America is headed that way, evidenced by Washington picking which businesses survive and which are left to fail, not to mention how much executives – high level and low – can be paid. So what's a person to do? There is no academic hemming and hawing with Goyette and don't be looking for stock tips. The author suggests investing in real things and he especially likes the yellow metal. What's especially valuable is the primer he provides for buying physical gold – something that many people ask about.

All the other ways of investing in gold are addressed along with a separate discussion about silver. Goyette knows the whole energy independence chatter is nonsense and spends a chapter discussing what the world will not be living without in our lifetimes – oil.

Specifics are provided on how to invest in other commodities and what to invest in to take advantage of the coming bond market crash. Goyette's explanation of how volatility can eat up an investment in leveraged funds is especially helpful as well as his tip about TIPS.

For readers who want more information, the author's suggested readings at the end of the book will arm investors with ongoing market and economic knowledge.

At the book's end Goyette's sadness of America's loss of liberty is evident. He worries what will become of this country's prosperity and freedoms. But he doesn't waste time urging his readers to write their congressmen or elect the right people. It's too late for that. Protect your assets, get out of the dollar.

Making Money In A Down Market

In 2008 almost everyone lost money. Almost everyone. A few made a profit because they would not remain in the box.

To make money today the investor must think outside the box as the market approaches the new tipping point. It looks like it is headed for a wide sideways pattern for the months ahead.

Most brokers have not been taught by their companies how to make money and few have any idea what to do when the market tanks. They look at each other with blank faces and ask what do we do now. Customers call either crying or screaming.

There are two basics brokers have heard of. Selling out and putting customers into a money market fund which their company will not allow or going short which most of them do not understand and their customers are afraid of with good reason. The latter can be very dangerous for the novice.

There is a third which some have heard of, but do not know how to use. There are both mutual funds and exchange traded funds that go up while the market is going down. Anyone can buy them. They are called bear funds. I made good use of them last year.

All investors are familiar with the S&P500 Index. It is one of the standard measurements of the stock market. There are many mutual funds that follow it exactly. It is an excellent investment while the market is rising. You don't want to own it while the market is crashing. Last year it lost about 40%.

There is an exchange traded fund with the symbol SPY that mimics it. Conversely there is an exchange traded fund with the symbol SH that is the mirror image is the SP500. It goes up while the SPY goes down.

The problem is brokers don't know when to sell out the long positions and buy the bear funds. There are several methods that work very well all of which Wall Street tells their brokers will not work.

How many times have you heard market timing doesn't work? It does. Several years ago the Federal Reserve wrote a treatise saying it outperformed the Buy and Hold method.

Using a simple 200-day moving average penetration will have a good broker watching to protect his clients. There are things called oscillators where two moving average lines crossing over give buy and sell signals.

If your broker or financial planner is not trained in these technical indicators it is time to change to a new advisor. If you don't know about them it is time you learned or you can watch your money disappear again in the next down sweep. Yes, I guarantee there will be another one; it is impossible to predict when.

Only technical indicators will show investors when to be in cash. Fundamental analysis will not.

An investor who learns to use bear funds will protect his capital and can make money while the market is crashing.

No, it's not the town I've come to hate. It's the people.

Las Vegas seems to be a sicko magnet. For all the nice people I've met here, I've met a dozen people that I wouldn't spit on if they were on fire. Sure, I'll have to drive to Reno or Vegas for any shows, but there are plenty of casinos and gaming to keep me busy, I hear the food is really good. Plus there's something up north that we don't have here. Something not permitted in this county. I doubt that Dolly Parton's running any of them, though... Prologue: On this Thanksgiving day, I am so happy that I trusted my instincts and brought the family to Northern Nevada.

Two years out from our move, and it was the right thing to do.

So many of the people that I knew in Las Vegas are unemployed, unable to find work. Some are gone, unable to be located unless I find a PI. Many couples split and went their separate ways, thinking it would be easier. Others have stayed together for the sakes of their bank accounts.

Truth be known, we had the roughest 2009 possible, but it's coming back. And so are we.

The local economy hit a huge rough patch. Some long-time businesses closed. Harry Reid rewrote our future here from a bright exclamation point to a huge question mark. Many, holding on for the redevelopment the coalfired plants would bring, gave up.

Commentary: Joyce Meyer

Watch Your Mouth! It Matters More Than You Think.

It's a simple message: "Watch your mouth!"

Have you ever said that to anyone? Or has anybody ever said it to you?

Most of us would probably agree that we need to think more before we speak. James 1:19 tells us to: ...Let every man be quick to hear [a ready listener], slow to speak... (The Amplified Bible).

Why? Because our words have power. The Bible says the power of life or death is in the tongue (see Proverbs 18:21).

So, what are you talking about? I think the three things we talk about more than anything else are what we want, what we think, and how we feel. And a lot of us spend more time thinking about what we're going to put into our mouth than what comes out of it.

We need to be aware of what we're saying because it's what comes out of us, not what goes in, that makes us unclean (see Matthew 15:11).

Our words reveal what's in our heart. They reveal the true character and level of spiritual maturity of a person. If you pay attention to what you're talking about, you'll learn some things about yourself.

The book of James has a lot to say about the words of our mouth. In James 3:2, we're told that anybody who can control their mouth and never say anything wrong can control everything else about their life. This means that what we say determines our direction in life – it either agrees with what God says and what His plan is, or it doesn't.

James 3:4-10 expounds on this. It compares the tongue to a bit in a horse's mouth. The bit, a small piece of metal, in the mouth of a horse can

turn the whole animal around. And a rudder on a ship, which is a huge vessel, determines which way the ship goes. Both the bit and rudder are small compared to the horse and the ship that they control.

Our tongue does the same thing for us. And because of it, our mouth is the biggest problem we have – not finances, people, jobs, or the world.

The bottom line of these verses is, the tongue determines the outcome of your life. Even though it's tiny, it can cause huge problems. It's frequently used by Satan to cause great harm. And the tongue can be tamed by no man, so we need God's help.

I believe the Holy Spirit tries to help us and give us guidance. It's that

uncomfortable feeling that you get in your gut before you say something you shouldn't. When I start talking about something I shouldn't, I feel it right away.

Now, the Holy Spirit won't make us do the right thing, but He'll remind us what's right when we need Him to. And when we're prompted by the Holy Spirit not to say something and do it anyway, we're basically saying, "I have conviction that this is sin but I'm going to do it anyway."

We need to be accountable for the words we speak. Confess your faults to someone you trust. Tell them when you say things you shouldn't have said. When we make ourselves accountable to someone else, it helps us behave better.

I also want to encourage you to pray some scriptures over yourself. Here are a few that David prayed:

❖ Psalm 19:14 Let the words of my mouth and the meditation of my heart be acceptable in Your sight, O Lord, my...Rock and my Redeemer.

❖ Psalm 141:3 Set a guard, O Lord, before my

mouth; keep watch at the door of my lips.

* Psalm 39:1 I will take heed and guard my ways, that I may sin not with my tongue; I will muzzle my mouth as with a bridle...

I'm so grateful that I've learned scriptures about the power of the words of my mouth. Before I understood this, I didn't think much about what I was saying and how it was affecting my life.

So I'll ask you again: What are you talking about? Do you really know what you're saying? Ask God to help you be accountable for the words of your mouth. He alone has the power to tame your tongue!
