Inside Scoop: **The Choice is Yours**

Choice: (definition) an act or instance of choosing; selection.

We make hundreds if not thousands of decisions every day, from what to wear, what to eat, how to get from point A to point B, how to achieve our goals and dreams, whether to remain in a situation or leave. Some choices we make seem easy, almost automatic and others are life-altering. Making a choice sometimes has an impact on others that is unintended and undesirable and the power to choose is one undeniable right and responsibility every living being with a brain on this planet has. How we handle an unhappy client, what resources are reasonable to utilize for a sick shelter pet, how we support each other when an adoption is returned or when an animal's suffering must end are just a few of the many challenging choices that must be made by shelter staff on any given day at Ark-Valley Humane Society. We are often faced with consequences of the choices that others have made such as buying a pet from a breeder or taking in a stray animal. When that pet bites due to lack of supervision, training and support, when that pet has an unintended litter, when that pet has extraordinary or expensive medical challenges, somewhere down the line that person has a choice to provide what is needed - or not. One of the most difficult choices a guardian must make is when to let a beloved pet go, whether it's

“over the rainbow bridge,” (Is my my pet suffering or ready to die?), to a friend, relative or ex (Will they take care of my pet the way I think they should?), or to a shelter or rescue (Will my pet feel abandoned or have a chance at another home?). Sometimes that choice is taken out of our hands because animals have choices, too. A pet may die suddenly or run away. When we consciously make decisions in the best interest of others, especially our beloved pets, we truly demonstrate selflessness which is essential to our humanity and being ‘humane’. This statement seems simple and yet these choices are not easy. The most critical and wholly personal choice that we can make in any given circumstance is **how** we choose to respond. The choices here are seemingly endless: anger, defensiveness, indifference, acceptance, gratitude, or understanding. The attitude we choose in the present moment makes all the difference between a positive outcome or emotional turmoil and suffering. That is powerful. It requires constant and thoughtful effort. It's not easy, and they say that nothing worthwhile ever is, but today, and every day, you have the power of choice. And that choice is yours...

AVHS Hosts 2nd Annual Pet Health Fair

On Saturday, April 27, 2013, AVHS will host its annual Pet Health Fair. Held at the Chaffee County Fairgrounds, this signature event will provide a venue for pets (dogs *and* cats) to obtain "one-stop-info" on everything pet-health-related. With generous participation from local veterinarians hosting screening stations with topics ranging from pet dentistry to behavior, it promises to be a veritable feast of information for pet owners in the area. Attendance is free and canine blood testing will be available for the exceptionally low price of \$35 per dog. AVHS will also be offering income-qualifying veterinary visit/voucher coupons to help offset costs associated with keeping pets up-to-date on core vaccines and wellness checks.

We take pet health very seriously. The AVHS Pet Health Fair aims to help identify potential health issues in dogs and cats whose owners would then see their local vet for detailed diagnosis and treatment. We hope many plan to attend with their dogs (on leash, please) from 12:30 to 4pm, or, earlier in the day with pre-registered cats (in a secure pet carrier, please) from 10 to 11:30am.

Visit with the vets, have your pet micro-chipped, chat with us about our Community Assistance Spay/Neuter program. Do you have a dog of questionable heritage? Canine DNA testing will be available for \$60 at the fair. We'll even have a vital signs check-station.

Pre-registration with payment is required for blood draws (dogs only) and preregistration is required for all cats. All other services, information, and screenings will be available on-site at the Health Fair on a first-come, first-served basis. Check our website for further details at www.ark-valley.org

We hope to see you and your pets, THERE! It's where all the cool Chaffee County Critters go.


The Sunshine Shelter Celebrates its 2nd Birthday!



The Sunshine Shelter celebrated 2 years of operations on March 1st, 2013. Since opening its doors, this facility has taken in 660 cats and 419 dogs (as of this writing) for a grand total of 1,079

critters since “day-one” in the south-county area.
