OVERTURE TO THE 138TH GENERAL ASSEMBLY RE FUND FOR MINISTERIAL ASSISTANCE - PRESBYTERY OF WATERLOO-WELLINGTON

RE: Eligibility requirements for the Fund for Ministerial Assistance

WHEREAS, the economic vulnerability of single persons, namely widows, irrespective of whether or not they have children (eg. Ruth) is a concern of the Older Testament, and
WHEREAS, the example of Jesus clarifies that marriage and children are not pre-requisites either of righteous life or of ministerial vocation, and

WHEREAS, the letters of St. Paul clarify that both the married and the single life are acceptable among the disciples of Jesus, the latter possibly more approved for those in ministry (I Corinthians 7.38), and

WHEREAS, the Reformed tradition has notable examples of ministers who, though married, did not have surviving biological children (eg. John Calvin, John Wesley), and

WHEREAS, the 2006 census marks the first time that married people were outnumbered by single people in Canada, and

WHEREAS, the 2006 census marks the first time that families without children outnumbered families with children, and

WHEREAS, the research of the Vanier Institute, published in its 2010 Families Count IV document, shows that single people are deferring marriage and having children owing to financial pressures, and

WHEREAS, the research of the Vanier Institute (2010), *vide supra*, also shows that while poverty rates for families have declined, they are still very high at 30-35% among working age singles, and

WHEREAS, the current face of the Canadian household, specifically in respects mentioned above, were unimaginable in 1951, the date of the Fund for Ministerial Assistance's original indenture, and

WHEREAS, the eligibility requirements under the terms of the original indenture, which mention "eligible married ministers" have already been "extended to include ministers who are divorced and have custody of, or financial responsibility for children" without perceived violation of the "spirit of the original indenture" (www.presbyterian.ca), and

WHEREAS, this extension seems to have inexplicably dropped the requirement on marriage while introducing a requirement about children, and

WHEREAS, children are clearly not the only source of financial stress (*viz.* the Vanier Institute's research on the *reasons* increasing numbers of Canadians are single and childless for longer (eg. the demand of the workplace for higher education, student debt, being financially not in a position to marry or to have children), and the reality that 30-35% of working age singles, without the aid of a double income to reduce debt faster and meet 100% of household expenses, are living in poverty), and

WHEREAS, the current eligibility requirements seem to be out of touch with the Bible and the Reformed Tradition's equal affirmation of the married and the unmarried and/or childless state for gospel ministry, and

WHEREAS, the current eligibility requirements seem not to recognize the practical need of many unmarried and childless ministers as being equivalent to those of married or divorced ministers responsible for the support of children,

THEREFORE, the Presbytery of Waterloo-Wellington humbly overtures the 138th General Assembly to reexamine the eligibility requirements for the Fund for Ministerial Assistance, and to be vigilant against other examples across the life of our church where single and/or childless people are shown that they are considered less “normative,” and less worthy of inclusion than those who are fulfilling “the creation mandate,” or to do otherwise as the General Assembly, in its wisdom, may deem best.

Appendix "A"

Report of the Congregational Affairs Committee Of the Presbytery of Waterloo Wellington

January 10, 2012

1) **St. Giles Presbyterian Church, Cambridge**

The church is currently facing the difficulties of lower attendance and financial problems. In May of the current year, St. Giles Church requested a grant of \$25,000 from Presbytery to try to stimulate being the church in a new way. The Presbytery gave \$12000 to the church, with the possible further support if results warranted. As the summer started, 16 members had made a commitment to be involved in training in order to start fresh programs for the church. However, in September only 6 persons were still available. The active members of the congregation, including the minister, are tired, weary, worn out and frustrated. During the Rev. Penny Garrison's ministry, there have been strong and vital programs with youth and children. At this time, however, most of the leadership for these programs is not able to continue, and the numbers of children and youth have dropped. In addition, the church faces a great challenge in meeting its expenses.

As of December 12, 2011 about \$1,000 of the grant money has been used to allow the church to explore new possibilities. The Session and Board of Managers met on December 7th, to explore their options for the future. The Rev. Jeff Smith (Crieff) attended the meeting, and moderated a portion of the meeting. A further meeting of these leaders is planned for early January to decide the next steps.

The agreement reached by our Committee is to put forward the **following motions**:

- 1) That the Rev. Jeffrey Smith and the Rev. Linda Ashfield represent Presbytery in supporting the congregation and the minister.
- 2) That Presbytery support St. Giles Presbyterian Church financially up to \$30,000 in 2012 so that it can look at its next steps, without the worry of being forced to close because it cannot meet its expenses. This financial amount would be inclusive of the balance of funds already given to the church (approximately \$11,000)

The committee believes that it would be helpful for the 4 churches in Galt (Cambridge) to look at their future, and how they can be supportive to one another. Rev. John-Peter Smit would be a good resource for this work. Rev. Angus Sutherland agreed to approach the other churches about this matter.

2) **Joonim Congregation**

Chris Ji Hoon Cho is going through the process to become a minister of the Presbyterian Church in Canada. During the vacancy at Joonim Church, Chris Ji Hoon Cho has been conducting services in Korean. Rev. Angus Sutherland reported that there has not been a good response in terms of candidates for the vacancy. At the same time, Chris Ji Hoon Cho's ministry has been well appreciated.

The committee puts forward the **following motion:**

That when Chris Ji Hoon Cho becomes eligible to be called to a church of the Presbyterian Church in Canada, Joonim Church be allowed to consider him for their vacancy.

3) **Ontario Disability Act**

Ontario Disability Act (re. churches) was briefly discussed based on an email sent by the Clerk of Presbytery.

4) **Report from Waterloo North Presbyterian Church to the Presbytery of Waterloo-Wellington Congregational Affairs Committee**

A. Commission Requirements:

With respect to the required reporting as outlined on page 11 of the Commission's final report, the congregation reports the following:

1. Rev. Sinasac has completed the required 12 Counselling sessions.
2. The program of reconciliation was discussed in our last report to Presbytery.
3. The congregation is implementing its Strategic Plan. The congregation completed the NCD before Christmas. The deadline for the Stewards by Design for 2011 was January; we will apply for 2012. As reported earlier, the spiritual gifts inventory was completed.
4. As reported earlier, the election of elders has occurred.
5. As reported earlier, others are serving as Clerk of Session and Treasurer: Dale Kurt and Dale McKee respectively.

We believe that we have met the requirements of the Commission, and that this will be our final report. This report is being presented to the CA committee in December, for the January Presbytery meeting.

Appendix "B"

Presbytery of Waterloo-Wellington Mission and Outreach Committee Report

The Mission Committee met on Wednesday December 14th, 2011 at St. Andrew's Presbyterian Church in Arthur. We had two main focus of discussion: 1) Ministry to post-secondary students and 2) Renewing the rural Church workshop.

Ministry to Post-Secondary Students

Our discussion focused on the possibility of holding a workshop, bringing people from the presbytery together to discuss and share different practices and come up with new ideas about how to minister to Post Secondary Students. As the discussion progressed it was evident that there are at three levels to this. The first level is how do we as individual congregations minister to students from our congregations. The second is how do congregations with a close proximity and or desire to reach out to students and people connected to Post Secondary Institutions. The third is how do we as a Presbytery minister to the Post-Secondary students. The following is excerpts from the survey that was taken last summer and the ministry committee meeting.

1. First level: Congregations caring for their students from their church or area
 - a. Some of the concerns are that of discipling in the Sunday school that sticks with the kids as they grow up and reinforces the faith that God has given them, helping them to mature and be committed Jesus followers. This is to ensure that when our youth grow up they don't leave the church at age 12 or when they go away to college or university.
 - b. Some of the practices of staying connected with post-secondary students have been:
 - i. Having someone that is dedicated to keeping in contact with them, whether it is through cards, gifts, phone calls, prayer requests and prayers, emails, facebook messages, generally showing them the love of Christ. Ideally this relationship needs to begin long before they are going off to university or college. This relationship could take the role of a mentor, or simply someone who has been present throughout the young person's life, whether taking a healthy interest in the person and the family, attending

sporting events, building up the relationship so that as the young person grows up they know that someone from the church cares for them as a person. If a relationship is strong you may want to think about giving a gift to some of the student's friends that you know and that know you. This could be part of the ministry of the church.

- ii. Celebrating milestones in their lives and achievements.
 - iii. Help them to get connected in their new city whether you are giving them contact names at churches/groups they would be able to connect with. If permission is granted to also contact the church/group and give them the student's contact information. Another suggestion is to be thinking ahead and in some cases you can be letting the students know what is out there before they are getting ready to leave.
2. Second level: Congregations in close proximity and desire to minister to Universities and Colleges
- a. Support/partner with the campus ministries/groups: Volunteer, donate time and use of the building, money. Some have hosted discussion/Bible studies for groups.
 - b. Hosting a blog for the students
 - c. Have a dinner for them, some churches have an after church, home cooked meal at someone's house and the university/college aged people are all invited. This becomes a place that people don't want to miss. You can have a discussion and get to know them.
 - d. Offer a shuttle service for the student to be able to come to church
 - e. Find a way to help at the university
 - f. Welcome a foreign/out of town student into your house for the holidays
 - g. Support congregations who are close to a university/college
 - h. Support the on campus chaplaincies
 - i. See the campus' as a mission field and the possibility of also Planting a church
 - j. Advertising on campus of the ministries and care you offer
3. Third Level : Presbytery Level
- a. Currently we are supporting the Ecumenical Campus Ministry (ECM) at the University of Guelph
 - b. We have supported Inter-Varsity Christian Fellowship in the past

- c. One presbytery sends out a request to Presbyterian churches for students that are in their bounds so that they can give them a gift
- d. Support existing campus ministries/groups
- e. As a presbytery we could look at planting a church in this context
- f. Questions we might want to consider:
 - i. How are these ministries furthering the Kingdom of God?
 - ii. How can we support ministries and groups/minister on the different campuses in our bounds?
 - iii. What are the specific needs?

From this discussion it was decided to hold off on a workshop until we can come to a consensus about what it would be about and look at getting people who have experience ministering in this area to put together a podcast that would be made available on the presbytery website and hopefully have some online discussion and sharing of ideas.

Renewing the Rural Church Workshop

This workshop is being planned for April 14th, 2012 at St. Andrew's Presbyterian Church in Alma. The speaker will be the Rev. Dr. Christine O'Reilly. There will be a lunch provided. Registration starts at 9:30am with the workshop starting at 10am and running until 2pm. There is a \$10 cost to help cover the cost of the meal. We will be applying for funding to cover the cost of the speaker, which will be \$800 of that it covers travel costs and a \$500 honorarium. We are also inviting neighbouring presbyteries to come and take part in the event. This would be a great event for Ministers, Elders, and other people in leadership. Come and learn.

Recommendations

- 1) That we proceed with the podcasts.
- 2) After meeting with the business committee, that a discussion day be held to focus on how the presbytery is funding ministry to Post-Secondary Students. This would include trying to get representatives from different campus ministries/groups to present what they are doing and how we could assist and/or come alongside them at the different institutions in our bounds. This would give us the opportunity to discuss and examine what we are and can fund and how this work is building up the kingdom of God.
- 3) That the funds to cover the speaker's honorarium and travel \$800 be used from the conference fund.
