

69th Annual **City Mixed Scotch Championship**

- **Eligibility:** This tournament is open to all amateurs age 18 and older who have an established GHIN Golf Handicap Index. Two-person teams/couples must be made up of one male and one female player. One half of combined handicap of players will be used. No two players can play with a difference of greater than 20 strokes between high and low handicaps. August 2011 handicap will be verified and used for team handicap.
- Entry Fees: \$120 per couple (fee does not include cart). Deadline for entries is August 15, 2011 no refunds after this date. Please call Greg Bisi, Tournament Director, at 916-224-1022 regarding cancellations or refunds. Please do not call the golf shop. Submission of an entry indicates willingness on the part of the player to abide by the rules and decisions of the Tournament Committee. There will be a \$20 service charge for all returned checks.
- **Form at:** Play will be 18-holes of golf. Each competitor must secure his/her playing partner. Two couples will be paired together if requested. The CHAPMAN FORMAT patterned after foursome play will be used. (1)Both partners hit from their own tee and then (2)each plays a second shot with the other's ball. (3)After the second shots, a choice is made regarding the ball to be used to continue, and (4)the hole is completed by using alternating shots until holed out.
- Rules: All play will follow United States Golf Association (USGA) Rules, and Local Rules posted by the Tournament Committee prior to play. In the absence of a Rules Official, competitors shall use Rule 3-3 (play a second ball) and refer any disputes to the Tournament Committee, whose decision shall be final. Players are responsible for returning their own attested and correct scorecard at completion of play (Rule 6-6b). Players are responsible for being on the tee when called, or an appropriate penalty will be assessed. If any point in dispute is not covered by USGA or local rules, the decision shall be made in accordance with equity. NOTE:The use of cellular phones/pagers or any similar equipment on the golf course during competition is prohibited. However, use of GPS Range and Distance finders may be used.

UNSPORTSMANLIKE CONDUCT—The use of abusive language, throwing of golf clubs, or other disruptive behavior will not be allowed—PENALTY: DISQUALIFICATION

Times/Check-in: All assigned times will be available at the Golf Shop and on the SGC website one week prior to the event. You may call the Golf shop at 916 808-2283 after the deadline to obtain your time, or you may call the tournament director, Greg Bisi at 916 224-1022 for help. Please check in at the Tournament Check-in table for tournament information and goodies prior to reporting to the first tee.
