#### Early Learning Assessment Update

We are excited to have over one hundred people complete the Training of Trainers for the Early Learning Assessment (ELA). The next step will be an Implementation Study completed by a small group of trainers and child care providers during the months of April, May and early June. The Implementation Study will provide additional feedback on using the online system and the ELA app.

Maryland Family Network has a grant with MSDE to provide funding to subsidize most of the cost for child care providers to receive the ELA training and the ELA kit. Please contact Jennifer Lentz (<u>jlentz@marylandfamilynetwork.org</u>) if you are interested in taking the ELA training. Participants will earn Core of Knowledge hours for the 12-hour training. Information and dates for training will be publicized later in the spring with training expected to occur during the summer and fall.

The ELA will have many benefits to child care providers. It is a formative assessment that defines the pathway of skills, knowledge and behaviors of children between the ages of 36 and 72 months. The ELA is aligned to the Maryland Early Learning Standards which establish the expectations for all children as the foundation for school readiness and life-long success.

#### Relevance

Child care providers can use the ELA to learn what a child already knows or does well and to inform instruction.

The ELA helps prepare children for kindergarten.

- The ELA, as a formative assessment, can measure a child progress over points of time to measure growth.
- Child care providers can use the ELA as a type of formative assessment to help qualify for Level 5 in Maryland EXCELS and/or meet accreditation requirements.
- Minimal cost since training and ELA kit expense are being subsidized. No cost involved once training has occurred. Use of Online system is free.

Special educators use the ELA for students with Individualized Education Plans

#### **Communication with Parents and Schools**

- The ELA provides information to teachers and parents of a child's progress on Maryland's domains of learning.
- The online system allows you to see, print and share information that shows a child's growth over a period of time. This is great information to share at parent teacher conferences.

#### Flexibility

- Child care providers can pick and choose which skills and in what domain (s) to assess based on the needs of the child and teacher.
- The ELA can be completed online all data is entered on a computer or tablet. A paper version is also available.

All items on the ELA are observational.

The online system can be used as a professional development tool with many informative and useful resources for teachers to use for planning instruction and addressing any special needs of children.

SETTING THE STAGE: ASSESSEMENT IN EARLY EDUCATION AND CARE focuses on working with culturally and ethnically diverse children, families, and staff members, as well as, working with children with special needs. School readiness remains the essential focus of Setting the Stage: Assessment in Early Education and Care. This is a 6 month commitment consisting of a 3 hour training, 2 mentoring sessions and a pre and post assessment. At the end, you will receive a certificate of **6 Core of Knowledge hours in Professionalism and earn 2 PAU's**.



A new offering from the Anne Arundel County Public Library (AACPL)

## Check Out Up to 99 Items for Six Weeks with No Fines!

#### Who's Eligible?

# Educators working in Anne Arundel County including:

- teachers
- college professors or instructors
- media specialists/librarians
- licensed child care providers
- homeschool parents, guardians

County residents who serve students outside of A.A. County are not eligible while educators who work in the county but who live in another county are eligible for a card.

#### How do I get the card?

Educators can apply in person at any of our library locations and must provide a driver's license or other valid form of identification that verifies their current home address; as well as proof of current teaching assignment.

#### Does the card expire?

Yes. The **Educator's Library Card** must be renewed at the beginning of each school year and will expire yearly on August 31, regardless of when the card was obtained the previous school year. All outstanding fines and fees must be paid on the educators and personal library cards before it will be renewed.

#### What can I check out?

The card is for classroom-related materials only. Entertainment DVD's, 7-day Express Material, eReaders, PlayAway Views, PlayAway Launch Pads, Londontown and Garden Family Passes, and MARINA/OCLC material cannot be checked out on an educator's card. Materials may be

renewed for two additional six-week periods.
