**Rescued!**

On June 1, 2007, volunteers from the Hill Country SPCA rescued twenty-three dogs and two tiny newborn Scotty puppies from a puppy mill, where the adult dogs' only purpose in life was to produce as many puppies as fast as possible.

These dogs were in dire condition, both physically and emotionally. They had spent their lives living in small, filthy rabbit hutches, or dirt floor cages barely having room to move around. They were teeming with fleas and internal parasites, had not been fed adequately, had received virtually no medical care, and had experienced only minimal human contact.

Sadly, one of the Scotty puppies died the day after coming to the shelter. The other animals, however, after more than two months "in the arms of the good guys," are enjoying better health, and their social skills are improving every single day. Eighteen of these rescued dogs have already been adopted and are enjoying their new 'fur-ever' homes.

Sincere thanks go to the staff and volunteers who spent countless hours helping these animals adjust to their new

lives. It took hours and hours of ... poop-scooping, hosing and bleaching runs, ...sitting in runs trying to convince the dogs that people can be kind and good, ...bringing chicken broth to entice tentative appetites, ...giving extra baths ... and teaching basic manners. The rewards - the first tentative tail-wag or gentle lick on a hand, followed up by the dogs' gradual building of trust and return to good health - made all the effort worthwhile.

Shortly after the rescue, Lovie, a Schnauzer, gave birth to a litter of seven, and Mindy, a Beagle mama, had a litter of six. And, now, the sounds of playful puppy barks and happy volunteers fill the Trudy Brune Hill Country SPCA

Truly, this rescue is the finest thing that the Hill Country SPCA has ever done. **(See Page 4 for pictures.)**

**What is a Puppy Mill?**

According to the Humane Society of the United States ([hsus.org](http://hsus.org)), a puppy mill is a breeding facility that produces purebred puppies in large numbers. The puppies may be sold directly to the public via the Internet or newspaper ads, at the mill itself, or they are sold to brokers and pet shops across the country.

The documented problems of puppy mills include over breeding, inbreeding, minimal veterinary care, poor quality of food and shelter, lack of socialization with humans, overcrowded cages, and the killing of unwanted animals.

To the unwitting consumer, this situation frequently means buying a puppy facing an array of immediate veterinary problems or harboring genetically borne diseases that do not appear until years later.

Sadly, some dogs are forced to live in puppy mills for their entire lives. They

are kept there for one reason only: to produce more puppies. Repeatedly bred, many of "brood bitches" are killed when they can no longer produce puppies.

Conditions in puppy mills are generally substandard and may be deplorable, and puppies and adult dogs may be malnourished, sickly, and of poor temperament.

## Puppy Mill: The Next Steps

On Monday, August 15, Chris Ward, president of the SPCA Board of Directors', addressed the members of the Gillespie County Commissioners' Court. Although most of the attendees at this regular monthly meeting were aware, after the fact, of the horrors found at the puppy mill from which the dogs were rescued in June, Chris reviewed the planning and activities leading up to the rescue and noted that county officials had not been notified ahead of time because of concern for both the animals and the rescuers. He then presented a two step approach to protecting domestic animals in the county and perhaps for preventing future puppy mill operations.

The first step, he said, is to make existing animal protections laws enacted by the State of Texas enforceable at the local level. Currently, enforcement of these laws must be done by a state law enforcement officer, i.e., by Texas Highway Patrol officers or Texas Rangers. If the commissioner's court were to enact ordinances based on these state laws, than local law enforcement officers, as well as state law enforcement officers, could work to protect domestic animals in our county.

As the second step, Chris recommended that funding for a new law enforcement officer be included in the budget and that this new person be responsible for animal welfare matters in the county. Currently, county sheriff's deputies

are called out when , for example, livestock are loose on highways, and time spent protecting the animals is taken away from their primary law enforcement responsibilities. An officer responsible for animal welfare would reduce this burden on the deputy sheriffs and would also be the primary enforcement for the new county animal ordinances.

Just as the city of Fredericksburg has a dedicated animal welfare officer, the Hill Country SPCA Board of Directors believes that the county needs a similar person. Board members plan to continue working with county officials on this and other issues relating to animal welfare in Gillespie County.

## Texas Laws Protecting Domestic Animals

**This is material extracted verbatim from "Overview of Texas Animal Cruelty Laws," by Ginna M. Ravenscroft**

In the eyes of the law, animals are generally regarded as property. Animals are bought and sold, used in various industries, and do not have individual rights. However, owners of animals cannot treat or use their animals in any way they wish. Rather state laws are enacted to protect animals from cruel and inhumane treatment.

In the state of Texas, numerous statues govern the treatment of animals. First, criminal laws are in place to prohibit cruel or inhumane treatment of domestic animals. Second, animals are protected from mistreatment by civil laws, which differ from criminal laws in their scope, enforcement, and penalties. Lastly, the Texas legislature recently passed in 2001 [sic] a set of laws that governs the keeping of dangerous wild animals. ...

Compared to criminal cruelty statutes of other states, Texas animal cruelty laws are very narrow in their scope... and only apply to any "domesticated living creature or any wild animal previously captured"... Under Texas criminal law, the intentional or knowingly cruel treatment of animals is expressly prohibited. Therefore, accidental or negligent actions cannot be prosecuted under cruelty statutes....

Texas laws define cruelty to include two general types of actions, unintentional actions and failure to act.

Intentional cruel actions include (1) torturing an animal, (2) transporting or confining an animal in a cruel manner, (3) killing, seriously injuring, or poisoning an animal... or (8) seriously overworking an animal. The state of Texas has criminal laws that specifically prohibit dog fighting.

Cruel treatment also includes situations where a person has failed to act or failed to provide care for an animal. Failing to act or failing to provide care rises to the level of cruelty when it involves either: (1) failing to provide necessary food, care or shelter, or (2) unreasonably abandoning an animal.
