The RMC and Bitumen division engages in the manufacture and sale of ready-mix concrete and bitumen. The Toll Collection Contract division collects tolls on roads and bridges owned and constructed by third parties. The company was founded in 1983 as Ashoka Constructions and changed its name to Ashoka Buildcon Private Limited in 1993. Later, the company changed its name to Ashoka Buildcon Limited in 2002. Ashoka Buildcon Limited

is headquartered in Nashik, India.
