These auctions are successful because of the generosity of our contributors and we are asking for your generous support again this year.

As one of the largest Catholic parishes in the Midwest, with 3700 registered families, our support to the local community reaches far and wide.

Your donation directly helps contribute to Epiphany's ministries including our monthly Family Table dinner which provides meals for those in need in our community, our Caring for Life program that helps provide families with infants with needed supplies, and our annual holiday program providing meals and gifts for over 150 local families each year.

Donations are sought in the following areas:

- **Live Auction Items** – The live auction typically features high retail value items such as fine jewelry, electronics, appliances, vacation packages, sports and entertainment experiences or professional services.
- **Silent Auction Items** – The silent auction typically features new items with at least a \$25.00 retail value. Popular items are gift items for children and adults, small household items, theme baskets, professional services or monetary gift cards/certificates
- **Gala Event Donations** – Donations of items such as food, liquor, decorating, etc. to offset our gala expenses
- **Cash Donations** – We welcome monetary donations which may be used to either purchase items for the live and silent auctions or to decrease our event expenses
