- 2. Conditional, unsigned, incomplete, telegraphed, or telephoned entries cannot be accepted.
- 3. Entrants are responsible for errors on or in their entries.
- 4. Entries will not be refunded in the event of errors or cancellation of entries after the published closing date, nor in the event that a dog is absent, disqualified, excused by a veterinarian or judge or barred from competition by action of the Trial Committee or because the dog is ineligible to compete due to incorrect entry.
