Four separate analyses of the data have been carried out,

- (1) "All" (641 respondents)
- (2) "Locals" (151 respondents)
- (3) "Closest" (76 respondents)
- (4) Blackheath Society Members (177 respondents)
- (1) "All" There were 641 valid responses (i.e. responses providing postcode details) to the online survey. In the report, although not all respondents answered all questions, they are designated as "All"
- (2) "Locals" 151 responses were from residents likely to have strong objections to the event as they were close to the event site. These 151 responses were from the following 35 roads as indicated by their postcodes:

- B. Attendance at the event by respondents, family member& acquaintances
- C. Perceptions of the vent first responses to news of the event, subsequent reactions to the event, attitudes to future events by commercial and non-commercial organisations
- D. Experience of the event inconvenience resulting from road closures, replacement bus service, sound impact, crowd behaviour and car parking, the complaints hotline.
- E. Impact on Local Business
- F. Comments for Lewisham Council

In each section there are references to responses by "All" respondents, "Locals" and "Closest" where relevant. In most sections, respondents were asked for additional comments. The number of comments by each group are shown in the boxes.

A. Information prior to the event.

Knowledge of the pre-event meeting was not widespread and consequently attendance by those most affected by the event was small. 38 (5.9%) of "All" respondents attended the pre-event meeting, with 31 (4.8%) finding it informative. Of the 151 Locals, only 84 (55.6%) knew about the meeting, 12 attended with only 7 (4.6%) finding it informative. Only 56.6% (43) of "Closest" knew of the meeting and only 6 attended. Even fewer (4) found it informative. This suggests quite clearly, that the organisers did not inform local residents adequately of the meeting to outline their arrangements for holding the event.

Respondents were asked if, prior to the event, they had received adequate information on road closures, changes to the 380 bus route, noise limits and the complaints procedure.

Just over half of **Locals** (86, 56.9%) and 47 **Closest** (61.9%) felt they had been given adequate info on road closures. Fewer **Locals** (63, 41.7%) and 38 (50%) **Closest** had adequate information on bus route changes. 63 (41%) of **Locals** and 33 (43.4%) **Closest** had info on noise limits. 65 (43%) **Locals** and 35 (46%) **Closest** knew how to register a complaint with the hotline.

B. Attendance at the event

Respondents were asked whether they had attended the event, whether members of their immediate family had attended, and whether their close neighbours or friends had attended. The purpose of these questions was to try to identify whether there were generational differences in respondents' attitudes to the event.

Of **All** responses, just under a third (29.5%, 189 respondents) attended themselves. However, 285 (44.5%) had members of their immediate family attend. 394 (61.5%) knew of close neighbours/ friends attending with the total figure of attendees being 1507, based on their estimates.

Of **Locals**, 32 of the 151 attended themselves, with 49 having immediate family members doing so. Over half (51.7%), said their close friends/neighbours attended, with 241 the estimated total number.

Of **Closest**, 17 (22.4%) attended, with 19 having family attending. 39 knew of close neighbours/friends attending, with a total of 113 attendances.

Use of the Heath for similar events

The opportunity was taken to seek the views of respondents on the **use of the heath** for events— and whether respondents differ in their views if events are commercial or charitable, non-commercial in nature.

Using an 11 point scale, respondents were asked to indicate their **strength of feeling** about fewer or more events on the heath.

The evidence is not really clear either way. Of **All** respondents, 311 (48.5%) think there should be **more** events, with 135 (215) scoring a 10, indicating strong feelings on the matter. On the other hand, 207 (32.3%) think the heath should be used for **fewer** events, with 101 scoring 0, indicating similarly strong feelings. 92 (14.4%) have no strong feelings either way on the matter.

33 (18.6%) **Members** scored 6 or more indicating they favour more events with 10 Members scoring 10 indicate the strongest feeling there should be more events. 54 scored 4 or less indicating they think there should be fewer events.

However, a large majority (111, 62.7%) feel there should be fewer events, with 57 (32.2%) indicating in the strongest way, scoring 0, that there should be fewer events. 33 were uncommitted.

37 (24.5%) of **Locals** think there should be more events, 84 (55.6%) fewer events. 13 (8.6%) scored 10 showing strong feelings for more events, 47 scored 0 showing strong feelings for fewer events

Only 10 **Closest** want more events, with 5 scoring 10, and 46 wanting fewer. 27 of the 46 have the strongest feelings on the matter (scoring 0).

Are feelings different if there is commercial or non-commercial, charitable involvement?

Of the 76 **Closest** residents, 43 (56.6%) want fewer commercial events, with 27 registering the strongest feelings. Only 14 feel the same way towards non-commercial ventures – i.e. that there should be fewer events. Only 5 people have strong beliefs on this. 9 think strongly (scoring 10) that the Heath should be used more for non-commercial events with another 37 supporting more events. Thus 61.9% of **Closest** residents are in favour of the heath being used more for non-commercial events. The optimum number of events respondents think the heath can support is 2 events.

Broadening the range of respondents to include the 151 Locals, a similar pattern emerges. Very few are against the use of the Heath for non-commercial activities with only 24 (17%) against. In contrast, 100 (71%) are in favour, with 22 (15%) scoring 10, indicating strong feelings for more events.

So it seems it is the commercialisation of the Heath which raises most strong feelings. People object far less strongly to non-commercial events than to commercial ones. In addition to those already well-established (e.g. the Marathon, Race for Life, circuses and fairs) the average number among all respondents was 3.3, local residents 2.6.

C. Perceptions of the event

This question asked respondents to indicate their attitude to the event, on a percentage scale, when it was first announced. A second question, using the same scale, asked about their reaction to the event in the light of their experience.

Both among "All" and most locals there was a move towards more positive attitudes. More than 550 people answered this question. Overall, there was a 14% positive shift among "All" respondents and a 10.7% shift amongst "Locals". Overall, there was a smaller but still positive swing among "Closest" by 5.9%.

There were 3 exceptions to this – the 18 respondents from Dartmouth Grove registered a very small negative swing of -1.0%., 8 respondents in Hyde Vale a negative swing of -7.4% and 10 residents of Wat Tyler Road a

-2.4% change. These were the only 3 exceptions to improved perceptions of the event in the light of experience.

In total, 36 respondents live in these 3 roads. A closer analysis of these 36 shows that only 8 of these 36 registered a negative change, while 6 of the 36 were considerably more positive (>+15%) with the remainder showing comparatively little change.

An analysis of **Locals** by age interestingly shows little variation by age, with the biggest attitudinal change among the 2 respondents over 80, who registered a 49% positive swing.

The biggest negative reaction however was from the 8 residents of Hyde Vale who recorded a -7.4% reaction. On closer inspection, however, only 3 residents of the 8 registered a negative perception.

D. Experience of the event

Respondents were asked to assess the level of inconvenience resulting from the closure of the Hare and Billet Road.

Road closures: 98 of the 151 **Locals** registered inconvenience caused by the closure of the Hare and Billet Road. 40 these registered levels of inconvenience at less than 50%, with 29 residents experiencing major inconvenience and recording 90% or more on the percentage scale. On a scale from 1 to 100, the average level of inconvenience registered was 56.6% which must be considered high. 18 respondents recorded a 100% level of inconvenience with 11 scoring in the 90s and a further 9 in the 80s. There is no doubt that these people experience high levels of inconvenience with **Closest** residents seriously affected.

The fact that pedestrian access was closed as well as road access was a particular source of annoyance, with a couple of comments also referring to aggressive guarding.

Comments on road closures: There were 134 Comments by All, with 99 by Locals.

Use of the Shuttle bus service: 134 people answered the question on use of the shuttle bus service. 16 of whom used it, and 33 finding the times convenient. However, 32 people said they did not find the times offered convenient.

58 respondents recorded having been inconvenienced by changes to the bus service with 14 respondents reporting 100% level of inconvenience. A further 8 recorded above 80% level of inconvenience. 15 reported single digit levels of inconvenience with a further 11 below 50% level.

The level of bus service inconvenience experienced by local residents was 21.6%, not surprisingly much less than the inconvenience caused by the closure of the roads

Sound awareness: Using an 11 point scale, with 5 as the median point, respondents were asked about their **awareness** of sound from the event. 255 respondents answered these questions. 78 recorded a 10 score, indicating maximum awareness, with 160 registering 5 or more on the awareness scale. 95 reported a score of 4 or less.

Sound intrusiveness: Using the same 11 point scale, respondents were asked how intrusive they found the sound. 192 found the sound intrusive with 30 **Locals** scoring it at the highest figure of 10. A further 41 **Locals** scored it between 5 and 9.

Local residents of course scored more highly. 60 registered a 10 on the awareness criterion, and 30 a 10 on the intrusiveness scale. This suggests that awareness of the sound did not necessarily mean that it was intrusively so.

Locals who found it most intrusive were residents of Allison Close (1), Chesterfield Walk (1), Dartmouth Grove (3), Dartmouth Row (5), Dartmouth Terrace (3), Eliot Park (4), Eliot Place (1), Hare & Billet Road (1), Hyde Vale (3), Oakcroft Road (1), Orchard Drive (1), St Austell Road (1), The Orchard (3), Wat Tyler Road (3), Westgrove Lane (1).

Interestingly, sound intrusiveness seems to have extended much beyond the expected areas inhabited by **Locals** and **"Closest"**. 7 residents of Lewisham with SE13 postcodes scored highly (above 5) on the intrusiveness scale. Bass was the major problem both for **locals** and **others**.

For **All** respondents, as might be expected living further away than Locals, the scores were low – registering 2.4 on the awareness scale and 1.5 on the intrusiveness scale. For **Locals**, however, the average score rose to 5.9 for awareness. However, despite awareness of the sound, it was less intrusive with a score of 4.5.

Crowd Behaviour and Car Parking: 446 respondents in total commented on crowd behaviour. This was not perceived as a problem for respondents, Locals or Members. 241 scored a 10 on the very well behaved scale. A large majority (346) scored 8 or more on an 11 point scale from not very well behaved to very well behaved scale. Only 16 scored less than a 5. Of the **Closest** respondents, 28 scored a 10 with 5 scoring less than a 5. Similarly, of the 118 Locals who responded, 54 scored 10 or more, indicating very well behaved. Very few problems were reported.

There were **53 comments** on crowd behaviour with the vast majority complimentary on the atmosphere.

Similarly **parking** was not a significant issue (only 46 Locals considered it an issue worth scoring at all) so respondents indicate a very low awareness of unauthorized parking. Inconvenience caused by parking was also very small with only 6 registering any inconvenience at all. However, 3 respondents, one each from Wat Tyler Road, The Orchard and Dartmouth Grove reported they were very inconvenienced scoring 10 on the parking scale.

The Organisers' Complaints Hot Line

10 respondents used the hotline provided by the event organizer. 2 of these found the response satisfactory, 4 unsatisfactory, 4 very unsatisfactory. 5 complained of the noise, 1 about the closure of the heath, 1 about the dangerous conditions forced upon the disabled crossing the heath and 1 complained about the promised local resident's discount which did not materialize.

E. Local Businesses

The questionnaire asked if respondents **owned** or **managed** a business in Blackheath or with an SE postcode. They were asked if they had been approached by OnBlackheath to see if they would be interested in participating in the event and if they had participated and if they felt the event had been good or bad for business. Finally, they were asked if they were satisfied with the opportunities provided by Heath based events to showcase their business.

67 respondents owned or managed business in Blackheath or with an SE postcode but only 10 of them had been approached by OnBlackheath to see if they wished to participate. Ultimately 8 businesses participated.

In all there were 42 comments on local business participation in the event. Comments made by businesses who did not participate give the following reasons – poor communication with the organisers, excessive cost and in one case, late cancellation by the organisers after the intended participant had made a considerable financial outlay. Large festival operators and big local businesses seemed to be favoured.
