Mid Island Air Monthly Club Budget Plan

If you prefer to pay your club dues monthly, our budget plan is for you. You receive all the same benefits of the Annual Flying Club (\$8/hour flight discount) or Gold Club (\$14/hr flight discount), without paying the membership fee up front.

You will have a one-time enrollment fee of \$25. After that, each month, for the next consecutive twelve months, you will be billed \$30/month plus tax for the AFC or \$45/month plus tax for the GFC. We will automatically bill your credit card for your monthly dues.

1. This is a contract and will become legally binding on you when you sign it. By signing, you certify that you have read the contract and understand your obligations under it.
2. This contract is NON-ASSIGNABLE and NON-TRANSFERRABLE.
3. NON-USE OF EQUIPMENT. Even if you fail to use our aircraft during the term of this agreement, you are still responsible for payment under this contract for the full twelve (12) month agreement.
4. DEFAULT. You will be in default of this contract if you breach any of the terms or conditions hereof. If you fail to pay your monthly dues, or if payment given is denied (returned check or invalid credit card), Mid Island can demand immediate payment of all unpaid installments.
5. CONSUMER RIGHTS OF CANCELLATION. You may cancel this agreement without penalty or further obligation within three (3) days from the date hereof. Notice of cancellation must be in writing and sent to MIAS at 101 Hering Drive, Ronkonkoma, NY 11779. Monies will be refunded within fifteen (15) days of receipt of notice of cancellation. You may also cancel this contract for any of the following reasons: a) if by reason of death or permanent disability under a doctor's order. B) if you move off Long Island or the five boroughs of New York, providing legitimate verification of move. No refunds will be given for partial month cancellation.
6. RULES & REGULATIONS. You are expected to follow all MIAS and FAA rules and regulations regarding any aircraft rental.
