Skills Needed for a W.I.T (Wrangler-in-Training)

A W.I.T. 2...

- A W.I.T. 2 is at least 15 years old at the time of your session and has successfully completed the W.I.T. 1 program.
- Is comfortable around horses.
- Can catch, lead, tie, and saddle for western riding safely and successfully on her own.
- Can mount and dismount on her own and ride at a walk, trot, and lope with ease and without fear.
- Can handle daily camp life for a week while upholding the G.S. Promise and Law.
- Can take direction from counselors, unit leaders, EQ, and administration staff.
- Can act responsibly under minimal supervision.
- Can remain healthy under the high temperatures of a Texas summer.

Responsibilities include the following:

- Waking up on your own.
- Working with your assigned barn staff member to catch, feed, saddle, and move around her assigned set of horses.
- Preparing your assigned horse for all riding activities and unsaddling them at the end of your day.
- Help campers on and off their horses at the beginning and end of each class.
- Pace arena classes (demonstrate the turns, trot, and lope as it applies to the arena class).
- Ride on trail rides and be alert to potential dangers while reassuring scared campers.
- Assisting your assigned barn staff member with her daily cleaning responsibilities as asked (sweeping, mucking and feeding stalls, etc.)
- Attending all camp events that occur in the evenings.
- Can walk from your living quarters to the barn without assistance after being shown the locations.
- Adhere to the Girl Scout Promise and Law.



A Day in the Life of a W.I.T.

All W.I.T.s report to the barn at 6:30 a.m. Monday through Thursday (Sunday and Friday have different times). At that time, the horses are caught, fed, and saddled before breakfast.

You will assist the barn staff during the following hours: From 9:00 a.m. to 12:00 noon, campers are at the barn either riding or participating in non-riding activities. You will leave for lunch at noon or after being dismissed. After lunch, W.I.T.'s return to the barn at 1:30 to assist the barn staff with watering the horses. From 2:00 p.m. until 6:00 p.m., campers are at the barn again either riding or doing non-riding activities.

W.I.T. 2s have the opportunity to visit the trading post and go swimming if they would like sometime during the day. This will be arranged through the Equestrian Program Manager and the pool and trading post staff.

On Friday, the W.I.T.s spend half a day (9:00 a.m. to noon) at the barn assisting with the end of the week activities.

The amount of riding time for a W.I.T. ranges from roughly two hours to three hours each day (broken up intermittently rather than all at once). These riding times can be spent either on trails or in the arena (depending on the day's activities). "Extra" riding time (at the end of the day or after dinner) is not available.

When you are not assigned to ride a particular hour, you will either be on the ground in the arena helping the barn staff assist the horseback campers, or you will be assisting with a non-riding activity (topics covered during these activities can include saddling, tack, grooming, bathing, anatomy, colors, etc.). If you're unfamiliar with these topics, it's a good opportunity to participate and learn with the campers, or if you feel comfortable with that subject, let us know and you can learn how to and/or help teach it to the campers!

**Please note that the times and days are subject to change as plans for each session are finalized by camp staff. Each week poses different sessions and activities; this schedule is just what is typically done each week.
