#### **TRANSFERS & WITHDRAWALS**

Candidates may transfer ONCE to the next sitting. Requests should be received IN WRITING before the closing dates above. Candidates may withdraw from an examination and under certain circumstances, fees will be refunded, less an administration charge. Requests must be made IN WRITING before the LATE closing date. Transfer and withdrawals will only be considered after the late closing date for medical reasons, supported by a medical certificate, or bereavement.

#### RESULTS

Examination results are issued by letter approximately 10 weeks after the sitting. Results will NOT be given over the telephone. (Pass lists are displayed on the Institute's website: http://www.sii.org.uk). They will not be given out over the telephone or by fax. Once released, results can be accessed on the Securities & Investment Institute website (www.sii.org.uk) under 'Exams & Training/Exams/Examinations Results'. Please use the candidate number and access code contained on your examination confirmation latter to view your exam result. *Under no circumstances will your results access code be given over the telephone*.

### **NOTES** (refer to form)

- Examinations may be held in London, Leeds/York, Birmingham, Manchester, Newcastle, Edinburgh, Dublin, Belfast, Guernsey, Isle of Man and Jersey. Sittings in regional centres will NOT be held unless candidate numbers are viable. Therefore please nominate an alternative exam centre in the box provided. Overseas centres may be set up by arrangement, provided sufficient notice is given and candidates will be expected to bear the additional costs in administrating the centre.
- 2) If you have previously taken examinations under a different name or address, please also include details of your former name/address in this section.
- 3) If your employer paid the entry fee, correspondence, including notification of results, will be sent to you at your employers address. Your employer will also be informed of your result. It is therefore important that any change of employer is notified to the Institute as soon as possible. If you are not in full-time employment or you are paying your own fees, please leave blank.
