Route 3

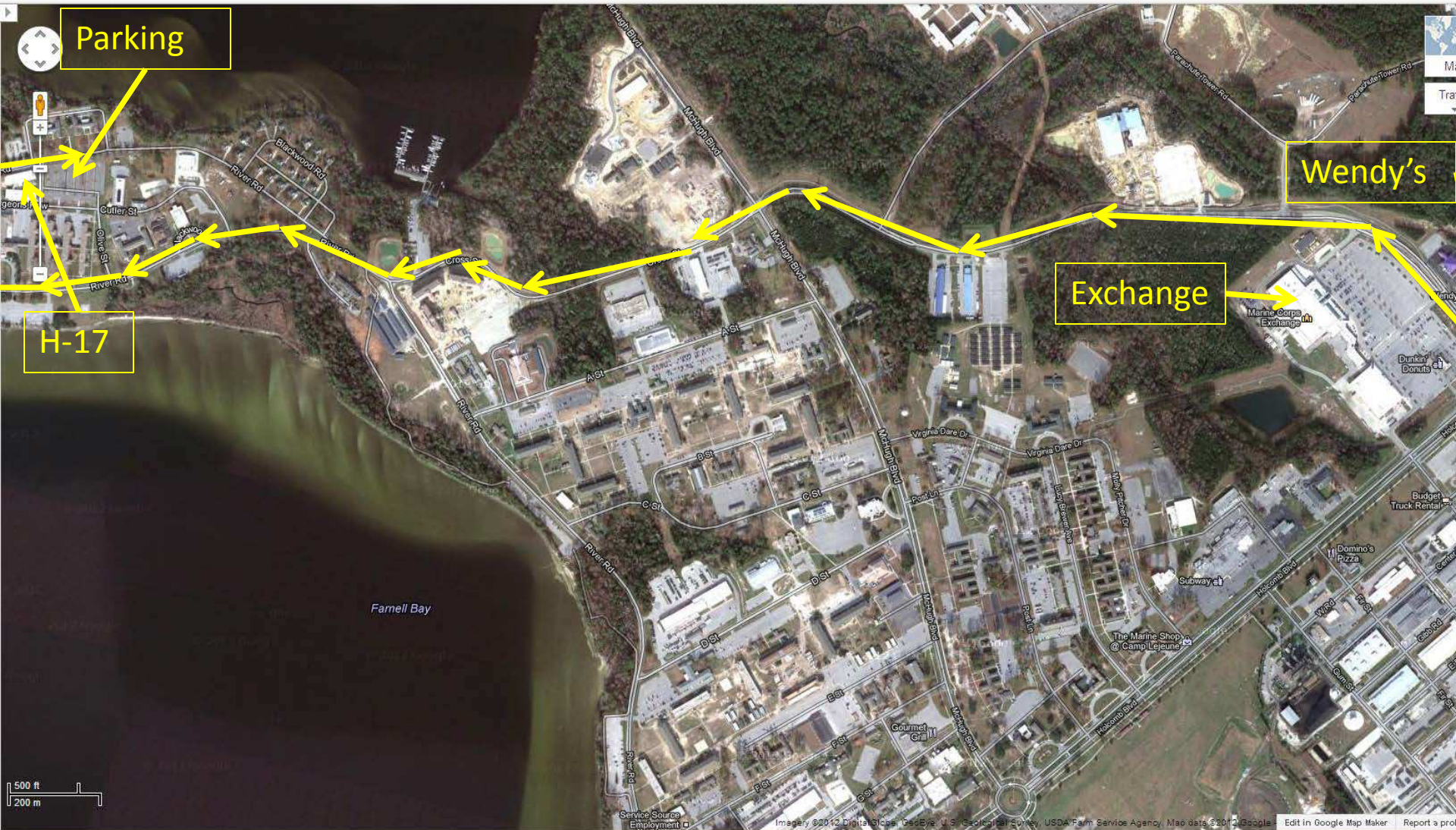
Continue from main gate onto Holcomb Blvd.
