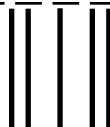

Limited Express Warranty Gas Furnaces

LIMITED FIVE (5) YEAR PARTS EXPRESS WARRANTY

All parts of the GDD, GDH, GUH and GUU Series Gas Furnaces are warranted to be free from defects in workmanship and materials for normal residential use and maintenance for five (5) years from the date of purchase by the original consumer for the original installation. The Limited Express Warranty applies only when the furnace is installed per Heat Controller installation instructions and in accordance with all local, state and national codes for normal residential use.

LIMITED SEVEN (7) YEAR EXTENDED EXPRESS WARRANTY

All parts are warranted to be free from defects in workmanship and materials for an additional seven years (for a total of 12 years) from date of purchase to the original consumer for the original residential installation when the furnace is properly registered by the original consumer within 90 days of purchase. Without registration, the warranty reverts to the **five year parts warranty** above.

LIMITED HEAT EXCHANGER EXPRESS WARRANTY

90%+ Gas Furnaces: The Primary and Secondary Heat Exchangers are warranted to be free from defects in workmanship and materials to the original owner for the original residential installation for his/her lifetime. For any subsequent owner of the residential property where the unit is installed, these Heat Exchangers are warranted for 20 years from the date of the original furnace purchase.

80% Gas Furnaces: The Heat Exchanger is warranted to be free from defects in materials and workmanship for 20 years from the date of original purchase.

HEAT EXCHANGER FAILURE

If the heat exchanger fails within 12 years of the original date of purchase, Heat Controller will replace the entire furnace. A Unit Change-Out labor fee of \$300 will be paid to the service company to replace the furnace. The owner is responsible for any additional labor, freight or miscellaneous charges. Registration within 90 days of purchase is required to qualify for this unit replacement warranty.

EXCEPTIONS

The Limited Express Warranty does not cover normal maintenance—Heat Controller recommends that regular inspection/maintenance be performed as set forth in the Owner's Manual. Additionally, labor charges, transportation charges for replacement parts, replacement of filters, and any other service calls/repairs are not covered by this Limited Warranty. It also does not cover any portion or component of the system that is not supplied by Heat Controller, regardless of the cause of failure of such portion or component.

CONDITIONS OF WARRANTY COVERAGE

- Unit must be operated according to Heat Controller operating instructions included with the unit and cannot have been subjected to accident, alteration, improper repair, neglect or misuse, or an act of God (such as a flood)
- Installation was done by a trained, licensed or otherwise qualified HVAC dealer/contractor
- Proof of proper maintenance must be supplied
- Performance cannot be impaired by use of any product not authorized by Heat Controller, or by any adjustments or adaptations to components
- Serial numbers and/or rating plate have not been altered or removed
- Damage has not been a result of inadequate wiring or voltage conditions, use during brown-out conditions, or circuit interruptions
- Unit remains in the original residence
- Extended warranty is valid only to the original purchaser (non-transferrable)
- Unit was not purchased over the internet

DURATION OF WARRANTY & REGISTRATION

The warranty begins on the date of purchase by the original consumer (homeowner). The original consumer must complete and return the warranty registration card or register at www.heatcontroller.com within 90 days of purchase. **The original consumer must retain a receipted bill of sale as proof of warranty period and also retain proof of the AHRI-matched system installation (if applicable).** Without registration and/or these proofs, the warranty reverts to the Five Year Parts Limited Express Warranty and the warranty begins on the date of shipment from the factory.

REMEDY PROVIDED BY THE LIMITED EXPRESS WARRANTY

The sole remedy under the Limited Warranty is replacement of the defective part. If replacement parts are required within the period of this warranty, Heat Controller, Inc., replacement parts shall be used; any warranty on the replacement part(s) shall not affect the applicable original unit warranty. Labor to diagnose and replace the defective part is not covered by this Limited Express Warranty. Ready access to the unit for service is the owner's responsibility. If for any reason the replacement part/product is no longer available during the warranty period, Heat Controller, Inc., shall have the right to allow a credit in the amount of the current suggested retail price of the part/product instead of providing repair or replacement.

LIMITATION OF LIABILITY

1. **EXCLUSION OF ALL IMPLIED WARRANTIES AND LIMITATION.** There are no other express or implied warranties. Heat Controller makes no warranty of merchantability. We do not warrant that the unit is suitable for any particular purpose or can be used in buildings or rooms of any particular size or condition except as specifically provided in this document. There are no other warranties, express or implied, which extend beyond the description in this document.
2. All warranties implied by law are limited in duration to the five-year term of the Parts Warranty. Your exclusive remedy is limited to the replacement of defective parts. **We will not be liable for any consequential or incidental damages caused by any defect in this unit.**

3. This warranty gives you specific legal rights and you may also have other rights which vary from state to state. Some states do not allow limitation on how long an implied warranty lasts or do not allow the exclusion or limitation of incidental or consequential damages, so the above limitations or exclusions may not apply to you.
4. No warranties are made for units sold outside the continental United States and Canada. Your distributor or final seller may provide a warranty on units sold outside these areas.
5. Heat Controller will not be liable for damages if our performance regarding warranty resolution is delayed by events beyond our control including accident, alteration, abuse, war, government restrictions, strikes, fire, flood, or other acts of God.

HOW TO OBTAIN WARRANTY SERVICE OR PARTS

If you have a warranty claim, notify your installer promptly. If he doesn't take care of your claim, write to Heat Controller, P.O. Box 1089, Jackson MI 49204. Enclose a report of inspection by your installer or service person. Include model number, serial number, and date of purchase.

Owner responsibilities are set forth in the instruction manual—read it carefully.

COMMERCIAL INSTALLATION LIMITED EXPRESS WARRANTY

When installed in a commercial application, all parts are warranted to be free from defects in material and workmanship for ONE YEAR from the date of purchase by the original consumer for the original installation. The compressor only is warranted to be free from defects in material and workmanship for FIVE (5) YEARS from the date of purchase by the original consumer. All conditions/exceptions/remedy/limitation of liability as described in this warranty document apply to commercial installation coverage except for references to "residential" installations. Registration is required for units used in commercial applications. Form No. 7954-1089 rev.11/12

LIMITED PRODUCT WARRANTY REGISTRATION

The limited warranty for this unit begins on the date of purchase by the original consumer. Return this registration card or register at www.heatcontroller.com within 90 days to record the date of purchase. If you don't register the purchase, the warranty begins on the date of shipment from the factory and you will not receive the benefit of the entire warranty term. By signing, the purchaser acknowledges that he or she has read the limited warranty for this unit.
