This involves board members that have big picture thinking skills as well as forward looking perspectives. 3. Another responsibility of our board is to evaluate and review the performance of the executive director. In addition to the direct evaluation of the executive's performance, this area involves ensuring that solid personnel policies, grievance procedures, and proper management of other employees are all being performed. This area also involves making sure our policies and procedures adhere to the existing by-laws and to make appropriate changes as needed from time to time to those by-laws. This area also provides guidance to the executive director to ensure we have efficient and effective organizational planning. 4. Another responsibility of our board is to provide adequate resources for the organization to fulfill our mission. This involves working in partnership with the executive director to raise funds from the community. This can either be within an operational context or capital funding campaign, whichever is needed. Typically, the best candidates in this area are well connected in the community or have specific experience in fundraising (although fundraising is every board members responsibility). 5. Another responsibility of our board is to manage our resources effectively. Our board, in order to remain accountable to our donors and the public, must help develop the annual budget and ensure that adequate financial controls are in place. In addition, we must ensure that the assets we have are being properly maintained and functional for the long term. Nominees skilled in this area might have a financial background and could serve on the finance committee or may be skilled in physical property management and could be effective on the building committee.
