2009 - 2010 HV INDOOR HOCKEY COMPETITION – Information Sheet

ACCEPTANCE CRITERIA:

The following criteria will be used as the basis for the acceptance of team applications:

1. Only Hockey Victoria affiliates may enter a team in the 2009-10 Indoor Comp. (All teams must be entered under an HV affiliate name).
2. Team entries will not be accepted unless lodged with completed entry form and deposit.
3. Team entry will only be accepted from fully financial HV affiliates.
4. All players must be registered players of a Hockey Victoria affiliate.
5. **For underage competitions, the player's age is determined by their age on 31 December 2009.**
Eg. To qualify for an Under 13 competition the player must be 12 or younger as at 31/ 12/ 2009
