**U.S. PERSONNEL MISSING FROM THE VIETNAM WAR:** There are now 1,788 US personnel listed as missing and unaccounted for by the Department of Defense. Recently, the identifications of three Americans previously missing/unaccounted for from the Vietnam War were announced:

Lt Colonel Paul E. Getchell, USAF, ME, MIA 1/13/69, Laos, RR 12-16-05, ID 11/20/06

Major Benjamin F. Danielson, USAF, USA, MN, MIA 12/5/69, Laos, RR 11/12/03, ID 8/6/046

Sergeant First Class Lewis C. Walton, RI, MIA 5/10/71, SVN, RR 10/19/04, ID 10/23/06

The League extends best wishes to the families and friends of these men and hopes that these final answers bring long-awaited peace of mind. The accounting for these Americans brings to 795 the number of US personnel accounted for since the end of the Vietnam War in 1975. Over 90% of the 1,788 still listed as missing were lost in Vietnam or in areas of Laos and Cambodia under Vietnamese wartime control.

**VIETNAM APPROVES USE OF U.S. NAVY SHIP FOR UNDERWATER RECOVERIES:** After more than a decade of consistent League efforts, reinforced in more recent years by the current and former Commanders of the US Pacific Command, ADM Tom Fargo (now retired) and ADM William J. Fallon, the Vietnamese leadership approved using US Navy vessels. The detailed approval process utilized for recent official USN port calls will be necessary, as will details of the specific mission proposed for such a recovery. Utilizing this US Navy asset won't be required for most shallow-water recoveries, but commitment from both governments to support the process if needed is a significant policy change by Vietnam and deeply appreciated by the League. We were pleased that ADM Gary Roughead, Commander of the US Pacific Fleet, raised this issue during his recently concluded visit to Vietnam as part of the evolving military-to-military bilateral relationship, as did Ambassador Charles Ray, Deputy Assistant Secretary of Defense for POW/MIA Affairs.

**DASD AMBASSADOR CHARLES RAY RETURNS FROM SOUTHEAST ASIA:** Ambassador Ray recently completed his first visits to Cambodia, Laos and Vietnam since being appointed DASD late last year. Southeast Asian government officials, US Ambassadors and JPAC were known to be eagerly anticipating his involvement and leadership on the issue. Ambassador Ray plans to hold a briefing on his trip in mid-February for family and veterans group representatives. Earlier last year, he visited Moscow to reinforce to the Russian Government the importance of naming a Russian Chairman as counterpart to US Chairman General Robert H. Foglesong, USAF (Ret).

Those of you who have different thoughts regarding the management of chapter 787 and how things have been handled in the past, now have a chance to step up and take charge!

## This Month during the War in Vietnam

**March 1968:** The U.S. Army's Charlie Company, 1st Battalion, 20th Infantry Regiment, 11th Brigade, Americal Division, and the incident at My Lai, South Vietnam.

**March 1969:** Nixon ordered the secret bombing of Cambodia. Intended to wipe out North Vietnamese and NLF base camps along the border with South Vietnam in order to provide time for the buildup of the ARVN, the campaign failed.

**March 1972:** When North Vietnam launched the offensive in 1972 it had every reason to be confident of victory. US forces had been gradually withdrawing from South Vietnam for the previous three years, mass demonstration against American involvement in the conflict, and South Vietnamese failure during [Operation Lam Son 719](#) added to the DRV's confidence. However, it was during this offensive that the North Vietnamese failed as the Army of the Republic of Vietnam ([ARVN](#)) put up heavy resistance and inflicted much damage on their opponents, the result was a military disaster for North Vietnam.

The offensive began on 30 March 1972, when 200,000 [People's Army of Vietnam](#) (PAVN) troops under the command of General [Vo Nguyen Giap](#), crossed the [Demilitarized Zone](#) and attacked the three northernmost provinces of South Vietnam. Rolling over the border outposts, PAVN then attacked the city of Quang Tri from the North and West. This wave of attacks was followed by offensives against Kontum Province on 12 April and the city of [An Loc](#), in Binh Long Province on 19 April. The second wave of the offensive was designed to split South Vietnam in two by driving through the Central Highlands to the sea. The attack on Quang Tri was met by heavy aerial bombardment by aircraft of the [United States Navy](#). [B-52 Stratofortress](#) bombers were used to extend the air strikes against North Vietnamese forces in the DMZ zone on 4 April, and into areas of North Vietnam on 10 April, in a bombing campaign unprecedented during the Vietnam War. The capital of [Hanoi](#) was bombed on 15 April.

Quang Tri fell to PAVN on 1 May. In response, the US and South Vietnamese withdrew from the [Paris Peace Talks](#) three days later, although talks resumed on 13 July. PAVN soon pressed the attack southward from Quang Tri southward toward Hue, where they were rebuffed with the assistance of American air support on [5 May](#). The US military reinforced aircraft by shuttling squadrons in from as far away as Japan and the continental US. The aerial armada continued to provide support to South Vietnamese troops, and began [Operation Linebacker I](#)

Simultaneously, the US continued to withdraw combat troops from South Vietnam, culminating in the departure of the last US combat troops from South Vietnam on 23 August. With *Linebacker I* underway, the PAVN offensive was slowed by supply shortages. PAVN withdrew from the offensive on Kontum on 30 May, and An Loc, which had been besieged unsuccessfully by the communists, was relieved on 11 July.

ARVN launched an offensive to re-take Quang Tri on 28 June, finally recapturing the city on 16 September. One-tenth of the DRV's air force was destroyed during the bombing campaign by the end of September.

April 1775, village green at Lexington, 200 British infantry led by Major John Pitcairn of the Royal Marines found its way blocked by a line of fifty American militiamen. The militia commander, John Parker, gave his orders: "Stand your ground. Don't fire unless fired upon. But if they want to have a war, let it begin here."

At nearby Concord, the British fired on the local militia and the American volley came back in force. Lt. Col Francis Smith of the British 10th Regiment of Foot, in command while on the return march home, was fired upon by American muskets from behind trees, rocks, fence posts, and all along the route, as militiamen from town after town turned out to fight the lobster backs. That these Americans were Indian fighters became apparent when the British troops found one of their own lying by the roadside: he had been scalped, ears severed, and brains removed, perhaps for a stew. *From the Book "Don't Tread on Me" by H. **Medal of Honor Winners of the Vietnam War.**  
**The Bravest of the Brave**



**OUELLET, DAVID G.**

Rank and organization: Seaman, U.S. Navy, River Squadron 5, My Tho Detachment 532. Place and date: Mekong River, Republic of Vietnam, 6 March 1967. Entered service at: Boston, Mass. Born: 13 June, 1944, Newton, Mass. Citation: For conspicuous gallantry and intrepidity at the risk of his life above and beyond the call of duty. As the forward machine gunner on River Patrol Boat (PBR) 124, which was on patrol during the early evening hours, Seaman Ouellet observed suspicious activity near the river bank, alerted his boat captain, and recommended movement of the boat to the area to investigate. While the PBR was making a high-speed run along the river bank, Seaman Ouellet spotted an incoming enemy grenade falling toward the boat. He immediately left the protected position of his gun mount and ran aft for the full length of the speeding boat, shouting to his fellow crewmembers to take cover. Observing the boat captain standing unprotected on the boat, Seaman Ouellet bounded on to the engine compartment cover, and pushed the boat captain down to safety. In the split second that followed the grenade's landing, and in the face of certain death, Seaman Ouellet fearlessly placed himself between the deadly missile and his shipmates, courageously absorbing most of the blast fragments with his body in order to protect his shipmates from injury and death. His extraordinary heroism and his selfless and courageous actions on behalf of his comrades at the expense of his life were in the finest traditions of the U.S. Naval

**Vietnam Vet to Get Medal of Honor**

A retired Army officer whose wing man in a Vietnam helicopter mission was awarded the Medal of Honor in 2001 has also been named to receive the nation's highest award for valor.

Retired Maj. Bruce P. Crandall, a native of Olympia, Wash, will receive the award from President Bush in a February 26 ceremony at the White House.



Crandall's heroics at Landing Zone X-Ray on November 14 1965, at Ia Drang, Vietnam were depicted in the 2002 film "We Were Soldiers." He flew an unarmed helicopter on 14 missions to rescue soldiers with the 1st Battalion, 7th Cavalry regiment, and resupply them with ammunition, despite intense enemy fire.

Crandall used three different helicopters, two were shot up so bad they would no longer fly.

## Social Security and Military Service

Week of February 12, 2007

If you served in the military from 1940 through 1956, including attendance at a service academy, Social Security may credit you with \$160 a month in earnings for military service from September 16, 1940, through December 31, 1956, if (1) you were honorably discharged after 90 or more days of service, or you were released because of a disability or injury received in the line of duty; or (2) you are applying for survivors benefits based on a veteran's work and the veteran died while on active duty. When you apply for Social Security benefits, you will be asked for your DD Form 214 or information about your reserve or National Guard service. 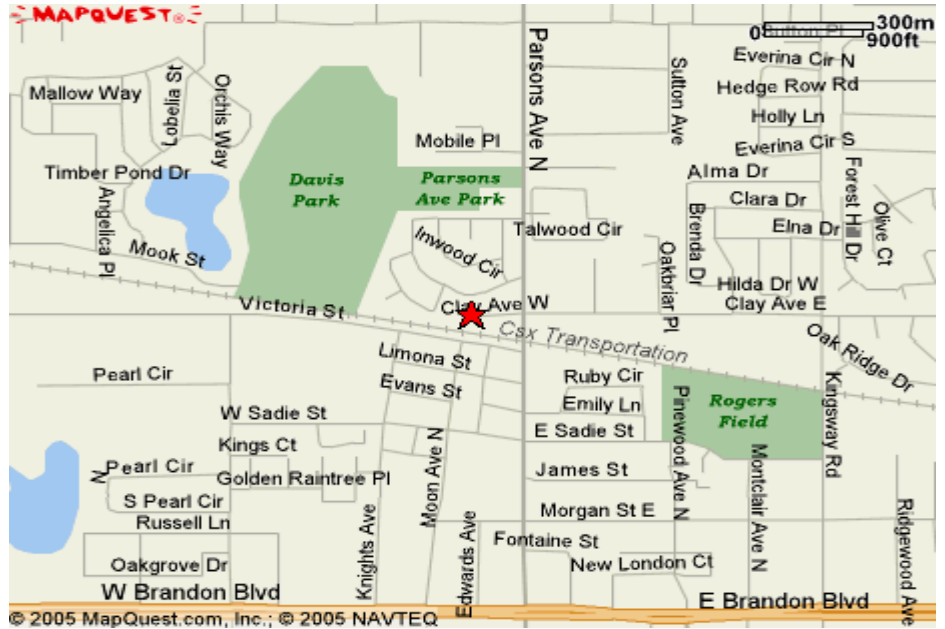
