1.	Fill out application completely, and submit to Bristol Management, 1930 Commerce Lane, Suite 1, Jupiter, Florida 33458, or fax to (561) 575-5423. Please allow 10 days for review and action to be taken by Waterway Condominium Association.					
2.	Above signed acceptance of the Rules and Regulations must be submitted along with the application, as well as, a copy of the lease agreement.					
3.	Please apply a minimum of 14 days prior to execution. Every effort will be made to expedite the notification process.					
4.	The required Transfer/Investigation fee of \$100.00 for each applicant (husband/wife are considered one applicant) paid by the owner must be attached to this application. By signing this application, the owner also acknowledges that they understand that the unit may only be rented once in a twelve-month period for a minimum of three months. \$500.00 refundable deposit for the Recreational facilities is required with the application.					
5.	All applicants must attend a personal interview with members of the Board of Directors. The Board will attempt to arrange an interview date within 10 days after receipt of this completed form. (All persons listed on the lease must attend the Board interview. In addition all applicants on the lease must provide a copy of their drivers' license.) No pets are allowed in rental units.
