If you cancel, you must make available to the seller at you residence, in substantially as good condition as when received any goods delivered to you under this contract or sale, or you may, if you wish, comply with the instructions of the seller regarding the return shipment of the goods at the seller expense and risk.
If you do make the goods available to the seller and the seller does not pick them up within 20 days of the date of you Notice of Cancellation, you may retain or dispose of the goods without any further obligation. If you fail to make the goods available to the seller, or if you agree to return the goods to the seller and fail to do so, then you remain liable for performance for all obligations under the contract.
To cancel this transaction, mail or deliver a signed and dated copy of this Cancellation Notice or any other written notice of send a telegram, to [Name of seller], at [address of seller] place of business] NOT LATER THAN MIDNIGHT OF [date].
