- Go to North Middle School website http://nms.sdmf.schoolfusion.us

- Under Technology Resources, select "PowerSchool Portal"
- At the next screen, enter your PowerSchool User Name and Password
- Click on "My Schedule" on the left side of the screen
- Scroll down to "14-15 Quarter 3." This is your child's schedule.

Please note that conferences are scheduled on a first-come, first-served basis. Each

request is stamped with the date it is received, and will be scheduled in that order. The completed form must be returned to the Attendance Office. Completed forms may be delivered to the Attendance office, mailed to North Middle School or faxed to 262-255-8412. If you share joint custody or are a non-custodial parent, please indicate your mailing address in the appropriate section of the Parent Conference Request form. A copy of your conference times will be mailed home.
