General Information

The NAEMSE EMS Instructor Course Part II has been designed and developed as a result of the DOT/NHTSA National Guidelines for Educating EMS Instructors. This course will provide educators and program directors with the tools and information needed to further build their leadership skills and better evaluate programs, students, and faculty. This course also includes an online portion that will enhance the two-day in-person sessions. Enrollment will be limited to 65 participants. Individuals who attend the entire course and pass the post test will receive a Certificate of Course Completion from NAEMSE with CEU's which is accredited by the Continuing Education Coordinating Board for Emergency Medical Services (CECBEMS).

COURSE REQUIREMENTS:

A portion of the course will be conducted online and includes educational material pertinent to the successful completion of the course. The NAEMSE textbook "Foundations of EMS Education" second edition is the companion text for this course and is mandatory. Payment information is provided below.
