Who we are

From its humble beginnings in 1953, The Centre has grown to provide over 2,700 children per year with 30,000 rehabilitation service sessions through 150 health sector staff from three locations Surrey, Langley and Delta.

The Centre for Child Development provides a “one-stop-shop” for children with special needs and their families providing specialized paediatric psychologists, occupational therapists, speech-language pathologists, key workers, physiotherapists, social workers, early childhood educators, supported child development program consultants, recreation specialists, a dietician and a doctor specializing in developmental paediatrics. The newest program under The Centre’s umbrella is Sophie’s Place Child Advocacy Centre; it is a collaboration between the Surrey RCMP, City of Surrey, Ministry of Justice (Victim Services), Ministry of Children and Family Development and The Centre for Child Development. The primary goal of Sophie’s Place Child Advocacy Centre is to provide an integrated, child-friendly space where children who have been abused mentally, physically or sexually can receive the necessary services from a multi-disciplinary team.

Statistics show individuals with a disability are four to five times more likely to be victims of abuse.

Why we need your support

It’s an exciting and busy time at The Centre for Child Development! We have just launched our Phase 2 Renovation and Expansion Campaign at a cost of \$1.7 Million. Thanks to our long time partner the Ministry of Children and Family Development we have received \$500,000 funding for 37 new child care spaces. We have begun the demolition of our very tired Preschool to make way for a new and improved Preschool; 37 additional child care spaces; renovation of our Communication Therapy offices and a second level that will house our Supported Child Development team with room for future expansion of our programs.

We need your support to help us raise the remaining \$1.2 Million cost of this Phase 2 Renovation and Expansion. Why? The South Fraser Region is currently home to 26,000 children and youth with special needs and our best estimates suggest that number may grow to 32,000 children and youth with special needs over the next decade. As our region grows so does the need for our services. The well-being, safety and success of our children is the highest priority we have.

TAX RECEIPTING GUIDELINES FOR AUCTION ITEM DONORS

For donations of items or gift certificates **valued at \$25 or above, charitable tax receipts can only be issued in accordance with Canada Revenue Agency (CRA) regulations and upon receipt of all required documentation**, such as a sales receipt or appraisal. If you wish to receive a charitable tax receipt for your donation, please complete this donation form.

The Child Development Foundation of BC (The Foundation) may issue a tax receipt for the following donated auction items:

Tangible, Material Goods:

The Foundation may issue a tax receipt for the fair market value of a donation of tangible, material goods. e.g., XYZ Electronics donates an iPad to the Gala of Hope auction. Proper documentation is required at the time of donation.

Gift Certificates that are NOT donated by the Issuer:

The Foundation may issue a tax receipt for the donation of a gift certificate when the donor has purchased the gift certificate and then donated it. e.g., an individual purchases an XYZ Electronics gift certificate and then donates it to the Gala of Hope Auction. (i.e., the donor is not also the issuer) CRA does not permit tax receipts to be issued for gift certificates received from the issuer of the gift certificate; however, a tax receipt can be issued through a cheque exchange. The issuer of the gift certificate would send the following to The Foundation:

1. The gift certificate
2. An invoice for the amount of the gift certificate
3. A cash donation in the amount of the gift certificate
4. A completed donor contract

The Foundation would pay the invoice for the gift certificate and send a charitable tax receipt for the amount of the donation.

If you or your business is donating a gift certificate for services, please note the following:

The donation of services such as restaurant meals, lessons, boat cruises, spa treatments, etc. are not donations of property and are therefore not eligible for a tax receipt. Some exceptions may apply and a cheque exchange as described above can be made in order to obtain a tax receipt.

Documentation required from the Donor if a tax receipt is requested:

All gift-in-kind items

The donor must supply proof of the current fair market value of the purchased/donated item by providing an itemized invoice, or sales receipt, or copy of a catalogue page or advertisement clearly showing the current fair market value of the donated item. If proof of current fair market value is not available, The Foundation requires an appraisal. For items with a stated value of \$1,000 or more, The Foundation will obtain the appraisal from a qualified independent appraiser. In order to be eligible for a tax receipt, the item purchased must be new, and must be in original wrapping and/or have all sales tags attached. Some exceptions may be made for items such as wine, artwork and jewelry.

Art, antiques, jewelry or rare and unusual collectibles

The donor must supply proof of the current fair market value of the donated item by providing an appraisal of the donated item. The appraisal must be done by a third-party appraiser who is qualified to appraise the donated item. The appraisal must be an original document on the appraiser's official letterhead and show the appraiser's name, address and qualifications. **As noted above, for items with a stated value of \$1,000 or more, The Foundation will obtain the appraisal from a qualified independent appraiser.** Items valued as "Priceless" are not eligible for a tax receipt.

The Foundation can not issue tax receipts for the following donated auction items:

Donation of Services

The Foundation cannot issue tax receipts for donated services (time, skills or effort) because services are not considered to be tangible property. Examples of other services include hotel accommodation, event set-up, entertainment, air miles, loaned vacation property, desk top services, or moving services. Some exceptions may apply and a cheque exchange as described above can be made in order to obtain a tax receipt.
