## First EVO South Asia Training and CMVP Examination

EVO organizes its South Asia Training on 19-21 November 2009 and CMVP examination on 21st November at India Habitat Centre, Casuarina Hall, Lodhi Road, New Delhi-110 003, India. EVO is conducting the CMVP Training and Certification in association with Alliance for an Energy Efficient Economy (AEEE-India) with support from USAID/ECO-III Project.

## Overview

## Protocols

Starting in the 1990s, standardized approaches to energy efficiency M&V were developed to assist developers, owners and financiers of projects. Today, the EVO - owned International Performance Measurement and Verification Protocol (IPMVP) is the leading international Standard in M&V protocols. IPMVP has been translated into 10 languages and is used in more than 40 countries. It is now typically cited as the basis for Federal, State and Utility M&V Protocols.

## Training and Certification Programmes

EVO provides training workshops for M&V professionals in order to raise the standards in M&V. Using its international expertise, the organization develops special workshops and training programs tailored to the needs of specific regions.

EVO offers worldwide the Certified Measurement & Verification Professional (CMVP) designation. The right to use the CMVP title is granted to those who demonstrate proficiency in the M&V field by passing a 4-hour written exam and meet the required academic and

## CMVP Exam and Certification

EVO Trainers will administer the four-hour CMVP Exam following the training. Those seeking the CMVP designation must meet the following requirements (in addition to passing the exam):

- Have an Engineering or Architect university degree or equivalent plus three years relevant experience;  
Or,
- Have a four-year unspecified university degree plus five years relevant experience; Or,
- Have a two-year technical degree plus five years relevant experience; Or,
- Have ten years of applicable experience.

Applicants must register for the CMVP exam by submitting an application to EVO in advance. If all eligibility requirements are met and a passing exam score is achieved, EVO will grant the CMVP certification.

## Registration and Costs - CMVP Training and Certification

Candidates are required to fill up the CMVP Examination Application Form in advance and thereafter the AEEE Registration Form with details of Fee payment.

The Training Fee is Rs 25,000 per candidate for the 3-day Training and CMVP Certification Examination. Two or more candidates from the same organization paying jointly will get a discount of 10% (i.e., Rs 22,500 per person). Candidates from member companies of Alliance for an Energy Efficient Economy (AEEE) will get a 20% discount on the full fees (i.e., Rs 20,000 per person).

Candidates would be making their own stay arrangements in New Delhi.
