## Agatha Berwanger Remembered

Agatha Berwanger moved to Torrance in 1954. By 1955, she had joined with other Torrance women in forming a local chapter of the League of Women Voters. The League was finally formed and recognized in 1962 with Ruth Nadel as President. Agatha Berwanger served as President the following term, 1963-64.

Agatha was an artist with a passion for politics. When her children were older, she became a case worker for the Los Angeles County Departments of Social Services, then Health Services. When they retired, Agatha and her husband Russ moved to Nipomo, where they had built their dream home, joining the "Torrance North Group". They were worldwide travelers and community volunteers. Russ passed away in 1998 and Agatha has recently passed away.

I first met Agatha Berwanger at a LWV meeting in 1962. She was conducting the meeting (and was wearing a hat!) She and her husband, Russell, co-wrote and published *Know Your Town*—a prerequisite for establishing a local LWV.

In her political activities she worked on a new library system and open space for parks. She and her husband, Russell, worked with me on electing Katy Geissert to Council and Mayor. They block-walked, silk-screened loads of lawn signs, etc.

Our two families socialized, traveled, and camped together. After they joined the "Torrance North" group in Nipomo, we visited them many times, and for years we have kept in touch by phone. I'll miss you, Ag.

### **The Census**

#### **What is the Census?**

The U.S. Census counts every resident in the United States, and is required by the Constitution to take place every 10 years.

**The 2010 Census will help communities receive more than \$400 billion in federal funds each year for things like:**

- Hospitals
- Job training centers
- Schools
- Senior centers
- Bridges, tunnels and other-public works projects
- Emergency services

The data collected by the census also help determine the number of seats your state has in the U.S. House of Representatives.

**Until you mail it back, we can't move forward.**

In March of 2010, census forms will be delivered to every residence in the United States and Puerto Rico. When you receive yours, just answer the 10 short questions and then mail the form back in the postage-paid envelope provided. If you don't mail the form back, you may receive a visit from a census taker, who will ask you the questions from the form.

The majority of the country will receive English-only materials. Households in areas with high concentrations of Spanish-speaking residents may receive a bilingual (English/Spanish) form.

Any personal data you provide is protected under federal law (Title 13 of The U.S. Code).

members will respond in support of the bill. SB 810 is moving through both houses in a single year as it was in suspension for most of 2009 along with all other legislation and could not move through the committees due to the budget crisis. Organizational endorsements, district lobbying visits, public forums, all need to be done for Senator Leno's SB 810 just as they were done for Senator Kuehl's bills. Ads are being developed to air via the internet and television during the coming year.

Nationally, the health care bills are being considered. The Senate bill does not include the public option, an important component according to LWVUS. Members are being urged to contact their Congress representatives and Senators to show interest in the public option. We are also concerned about a clause that would preclude States from setting up their own health care plans.

Responses to Calls to Action are increasingly important. Additionally, the LWVTA Board has sent a message to the LWVUS Board asking that Health Care Legislation be considered a priority on the National level and that the Board concentrate on educating the public on the value of a single payer style plan. State and local leagues across the country are working toward producing workshops, holding caucuses and supporting a resolution that would support the single payer effort.

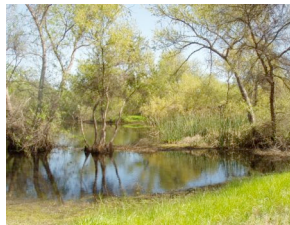

### **LWV/LA County Convention**

LWV/LA County has set March 27 from 9:30 AM to 2 PM for its annual convention. County Supervisor Mark Ridley-Thomas is to be the featured speaker with program planning also on the agenda. Watch for location and other details.

### **LWVC Co-Chairs California Fair Elections Campaign**

The California Fair Elections Campaign in mid-January announced that LWVC, the California Clean Money Action Fund, California Common Cause, and the California Nurses Association would co-chair the campaign to pass the California Fair Elections Act. This measure would establish a voluntary campaign spending limit for elections for Secretary of State in 2014 and 2018.

If passed, the California Fair Elections Act would impose strict reporting requirements and prohibitions on campaign spending for participating candidates. Participating candidates would be banned from raising or spending money beyond the limited public financing. Violators would face fines, possible jail time, and prohibitions from running for office in the future.

The Governor has signed the measure.

LWVC President Janis R. Hirohama has sent out an appeal urging interested leaguers to apply.

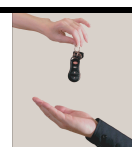
As a commissioner, you will help draw fair electoral districts in which voters choose their elected officials, instead of politicians choosing their voters....

Here's why it's so important that ordinary citizens—people like you—apply to serve on the commission. For decades, the state legislature designed the electoral districts for legislative, Congressional, and state Board of Equalization seats. The system was rife with self-interest and backroom deals. The result? Strangely-shaped districts that practically guaranteed reelection for incumbents—protecting the interests of politicians and political parties while ignoring community interests.

Under Proposition 11, the new Citizens Redistricting Commission, using a fair and open process, will draw the lines. This important task is now in the hands of ordinary citizens, not politicians.

### Grading the Obama Administration

This month the US League of Women Voters and other groups published a report grading the Obama Administration on its first year of achievements in the areas of ethics, lobbying and government transparency. They identified and gave grades to seven areas where the administration had implemented government reforms.

- Revolving Door Lobbying Ban – A
- Open Government – A
- Reverse Revolving Door Restrictions – A
- Lobbyist Gift Ban – B
- Preventing Lobbyists from Serving on Advisory Boards – B
- Restrictions on Seeking Stimulus Funds – A
- Restrictions on Seeking Financial Bailout – No Grade

### February 14<sup>th</sup>—The League's Birthday

From the spirit of the suffrage movement and the shock of the First World War came a great idea—that a nonpartisan civic organization could provide the education and experience the public needed to assure the success of democracy. The League of Women Voters was founded on that idea.

In her address to the National American Woman Suffrage Association's (NAWSA) 50<sup>th</sup> convention in St. Louis, Missouri, in 1919, President Carrie

Chapman Catt proposed the creation of a league of women voters to “finish the fight” and aid in the reconstruction of the nation. And so a League of Women Voters was formed within NAWSA composed of the organizations in the states where woman suffrage had already been attained.

The next year, on February 14, 1920, six months before the 19<sup>th</sup> amendment to the constitution was ratified, the League was formally organized in Chicago as the National League of Women Voters.
