All tests will run a single course with a bird field. Pheasants and/or chukars, and/or quail, and/or pigeons will be used.

PRIZES

Standard AKC Rosettes to all passing dogs.

OPTIONAL EVENT ALLOWANCES

Usages of tracking devices as specified by AKC rules and regulates will be permitted during these events.

IMPORTANT NOTICES REGARDING THE EVENT DAY

Please check in with the test secretary upon arriving on the test grounds. An outer blaze orange jacket, shirt, or vest must be worn by all persons that enter the course or bird field during senior and master tests.

The hunting test grounds will be the Keeton's Farm, except the Kennel area and the house.

All live fire on the hunting test grounds the **entire day of the test** must be supervised by the Captain of the Gun.

Please notify the test secretary if you handled a dog that passed and were not listed as handler on the entry form. A 2008 AKC rule change requires accurate handler recording for dogs with qualifying scores. Please dispose of dead birds and dog waste in designated areas.

APPRENTICE JUDGE OPPORTUNITIES

The German Shorthaired Pointer Club of Ohio supports those striving to become a hunting test judge. Please contact the event secretary if you would like to apprentice judge. Apprentice positions are limited to one per event and are award on an as received basis.

IMPORTANT NOTICES REGARDING ENTRIES

Entries will close at 5:00 PM local time, Thursday, November 19, 2009 with the test secretary at 6617 Springbrook Dr., Pickerington, Ohio. Drawing will take place at 10:00 PM local time Thursday, November 19, 2009 at the same address.

Entries limited to the number of dogs that can be run during available daylight hours. Entries will close when this limit is reached if this occurs prior to the specified closing time. Those entries received after said limit has been reached will be placed on an alternate (waiting) list according to postmarked date of received entry, and entrant will be notified of this.

Entries open to all AKC pointing breeds six months of age or over on November 21/22, 2009 that are part of an AKC registered litter or that have been individually registered with AKC. Bitches in season are not eligible to participate.

Entries must be on official AKC Field Trial or Hunt Test entry form (enclosed.) Phone, fax, or e-mail entries will not be accepted. Deliveries requiring a signature will not be accepted. No entry shall specify any conditions as to its acceptance.

Entries that are incomplete (including unsigned entry forms) do not constitute a valid entry and will be returned. An entry form must be filled out for each dog **and** for each day entered.

Entries without correct fees (including returned checks and checks dated after the closing date) do not constitute a valid entry and will be returned. Fees must be payable in U.S. funds. A \$25 service charge will be applied for each returned check.

Entry fees will not be refunded in the event that the dog is absent, disqualified, excused, or barred from competition by the action of the test committee. Entry fees will be refunded for bitches in season if the test secretary receives such a request in writing before the dog is called to the line.



Driving Directions from I-71:



- 1. Take I 71 to Exit 140 (State Route 61)
- 2. Take SR61 North for about 1.7 miles to SR 229. There is a stoplight at this intersection. Make a LEFT onto SR229.
- 3. Take SR229 West for about 2.1 miles to CO. RD. 24, (Worthington New Haven Rd.). Make a RIGHT.
- 4. Take CR24 for about 3.2 miles to Township Rd 155 (Waldo Fulton Rd.). Make a LEFT.
- 5. Go approximately 1.4 miles on Township Rd. 155, to a four way stop. Go **STRAIGHT** through this intersection.
- 6. The Hunt Test is at the second house on the RIGHT, about 0.5 miles.
