## **OVERVIEW**

The purpose of the Tribal Child Protective Services Training Academy is to meet the ongoing training needs of tribal workers for core training in the identification, intervention and treatment of child abuse and neglect. The Tribal Child Protective Services Training Academy is consistent with tribal strengths, resources, priorities, and concerns which parallel Indian child welfare practice.

## WHO SHOULD APPLY

The training is designed for Tribal social services staff, health workers, law enforcement officers, Tribal Court Staff and others who deal with child abuse and neglect. The academy will be limited to **25 participants** and will require a **two week** commitment. Priority will be given to new Tribal Child Protective Services workers.

## **CPS ACADEMY INSTRUCTORS**

The training instructors are compromised of physicians, psychologists, social workers, attorneys, law enforcement personnel; along with, federal, state and Tribal workers who are experts in the delivery of child protective services.

#### **REGISTRATION FEE**
