Healthy Workplaces Healthy Families Act

Governor Jerry Brown recently signed AB 1522 (the Healthy Workplaces, Healthy Families Act of 2014) into law.

It will be only the nation's second statewide mandate requiring sick leave be provided by employers. This law is complex, and has many possible consequences for California employers. Employment lawyers, house counsel, and HR administrators will want to be well-informed on the bill's requirements and its effects.
