***Rank-in-Class Roster* Instructions and Reminders**

- A *Rank-in-Class Roster* must be completed for any student who should be considered for an HSSP award but does not appear on the *HSSP 6th Semester Academic Information Roster*. Please use unweighted GPAs. Only students who rank in the top 50% of the class should be considered. If a school ranks, the ranks should be based on the unweighted GPA. **The sixth semester is defined as the third semester prior to graduation.** Some reasons a student would be added to the *Rank-in-Class Roster* include:
 - a student who ranks in the top 5% of the class as of the sixth semester, June 30, 2012, but does not appear on the *HSSP 6th Semester Academic Information Roster*;
 - a student who has transferred to your high school from another high school prior to completing the sixth semester; or
 - a student with an invalid graduation date and/or invalid grade level as part of their test results.
- High schools complete the roster by providing this information (**list students alphabetically by last name on the roster**):
 - the class size at the end of the sixth semester;
 - unweighted GPA scale
 - student's name (last, first, and middle initial);
 - student's Social Security Number (student ID number is acceptable if that's your only option);
 - student's address;
 - student's date of birth;
 - student's rank-in-class and GPA (unweighted) at the end of the sixth semester;
 - ACT or SAT scores for all tests taken between September 1, 2011, and June 30, 2012;
 - the test date of each test reported;
 - the high school's name;
 - the six-digit ACT high school code number;
 - the high school's address.
