What should I do if I want to make or change my Will?

Should you decide to make a change to your Will, or bequeath a legacy to BPF in a new Will, you should consult a solicitor. The form of Codicil below could be used, but please ensure that it is attached to your original Will. (A Codicil is a legal supplement to a Will)
