#### Application for Canadian Citizenship

#### **Canadian Travel Document Photo Instructions**

**Note**: Photo specifications for the travel document are different from those for a permanent resident card.

You must submit **two (2) identical photos** with each Canadian travel document application.

#### The photos must:

- be taken by a commercial photographer;
- be clear, sharp and in focus. Photos may be in colour or in black and white;
- have a neutral facial expression (eyes open and clearly visible, mouth closed, no smiling);
- · have uniform lighting-no shadows, glare or flash reflections;
- be taken **straight on** with the face and shoulders centred and squared to the camera;
- be taken in front of a plain white or light-coloured background to clearly distinguish the person from the background. Photos must reflect/represent natural skin tones;
- be originals that **have not been altered in any way** or taken from an existing photo;
- reflect your current appearance (taken within the last twelve (12) months); and
- be professionally printed on plain, high quality photographic paper (photos printed at home and photos printed on heavy weight paper are not acceptable).

#### The following must appear on the back of one photo

- The name and complete address of the photo studio and the date the photo was taken. The photographer may use a stamp or handwrite this information (stick-on labels are not acceptable).
- The guarantor's signature.

#### **Additional information**

- Glasses, including tinted prescription glasses, may be worn in photos as long as there is no glare and the eyes are clearly visible. The red-eye effect and sunglasses are not acceptable.
- Hats and head coverings must not be worn, except for religious beliefs or medical reasons. However, the head covering must not cast shadows on the face and the full face must be clearly visible.
