# **DEQ's Vehicle Emissions Test**

### Are you required to take DEQ's Vehicle Emissions Test?

The Oregon Department of Environmental Quality's Vehicle Inspection Program (DEQ-VIP) helps maintain clean and healthy air in the Rogue Valley area.

Most vehicles that are 20 model years old and newer must visit the DEQ's Rogue Valley Clean Air Station to ensure the vehicle's emission equipment works properly before a vehicle registration is issued or renewed by Oregon Driver & Motor Vehicle Services (DMV).

#### Vehicles that MUST be tested:

If you received this document in the mail with your DMV registration-renewal form, DMV records indicate your vehicle is within the DEQ vehicle emissions testing boundary and your vehicle must be tested if one or more of the following applies:

- 1. Vehicles that are **20 model years old and newer** including all newer cars, trucks, vans, motor homes and buses powered by gasoline and/or "alternative" fuels (such as propane, natural gas, etc.) and hybrids.
- 2. **"Light-duty" diesel-powered vehicles** with a manufacturer's gross vehicle weight rating of 8,500 pounds or less.
- If your vehicle is registered within the vehicle inspection boundary but is temporarily located in another state, contact DEQ's Vehicle Inspection Program toll free at (877) 476-0583 for information about testing requirements.

#### Vehicles EXEMPT from testing:

- 1. **Heavy-duty diesel-powered vehicles** (gross vehicle weight rating of 8,501 pounds or more.)
- 2. Vehicles legally registered outside DEQ's Vehicle Inspection Program boundaries. If your vehicle is exempt, fill out the *Declaration of Exemption* (on other side) and return to DMV with your registration or renewal. - 3. Motorcycles and Low-speed vehicles (golf carts, tractors, all-terrain vehicles, etc.)

### Ten Steps to Help You Prepare for the DEQ Vehicle Emissions Test:

- 1. Locate DEQ's Rogue Valley Clean Air Station (please see other side of this form or call for directions).
- 2. Make sure no warning lights are illuminated and your vehicle is in good working condition. Emission equipment must be intact and functioning. Missing or tampered emission equipment will cause the vehicle to fail.
- 3. Drive at least 10 miles before the test. Warm up your engine to ensure normal operating temperature.
- 4. Please keep your vehicle's engine running while waiting for the test.
- 5. Be prepared to exit your vehicle if it is 1996 or newer.
- 6. Please leave your pets at home. Smoking and cell phone use are **NOT** allowed in the testing lanes.
- 7. The fee for DEQ's Vehicle Emissions Test is always \$10. No pass = No charge.
- 8. Enjoy **one-stop service**. You can get tags and pay your DMV fees at the DEQ station! Registration and renewal fees from DMV will vary.
- Fill out sections 1 & 2 on the DMV registration renewal form. One of the registered owners MUST sign the form.
- 10. DEQ can only accept **CASH or CHECK**. Write the check **after** your vehicle passes.

#### Renew your DMV registration and get your tags at the DEQ Clean Air Station!

Oregon DEQ and the DMV are working together to serve you better. For your convenience, you may renew your DMV registration and receive your tags at DEQ's Rogue Valley Clean Air Station! If you decide to do this, here is what you need to know:

DEQ accepts CASH OR CHECKS ONLY! Credit and debit cards are not accepted.

#### The fee for DEQ's Vehicle Emissions Test is \$10.

#### Registration and renewal fees from DMV will vary.

There is no charge if your vehicle does not pass the test, however you will be unable to proceed with your DMV registration.

You may pay cash or write **ONE CHECK** (payable to DMV) for the registration fee and the DEQ Vehicle Emissions Test fee. Do not write the check until your vehicle passes. Your DMV registration fee may vary depending on where you live, your vehicle type and plates.

Please complete sections 1 and 2 on the DMV registration renewal form (included with this document) before arriving at the DEQ Clean Air Station. One of the registered owners MUST sign the renewal form.

Vehicles with commercial "T-Plates" may not renew their registration at DEQ's Clean Air Stations.



Please remember: DEQ cannot accept credit or debit cards. For safety, please leave pets at home if possible and please no smoking or cell phone use in the testing lanes.

#### What is the test procedure?

Vehicle model year determines the appropriate test:

1996 to current **On-Board Diagnostics (OBD)** 1995 to 1984 **Basic Emissions Test** 1983 and Older No Test

#### **On-Board Diagnostics (OBD)**

OBD consists of a scan tool that plugs into the vehicle's computer and checks to make sure emission systems work correctly. OBD is quicker and more accurate than the basic test. During the OBD test, you will be required to briefly exit your vehicle so the inspector can plug the scan tool into your vehicle's computer.

#### **Basic Emissions Test**

The Basic Emissions Test analyzes emissions for hydrocarbon and carbon monoxide. The vehicle is placed in neutral and idles for 30 seconds. After that, it is taken to 2500 revolutions per minute for 30 seconds, then idles for another 30 seconds.

If your vehicle is exempt from emissions testing for registration or renewal, fill out and detach this form and return to DMV with your registration or renewal.
