Captain's Meeting: 7pm CDT, Wednesday, July 6, at **Island Cove Marina** Clubhouse located on Bayou Chico, 806 Lakewood Road, Pensacola, Florida 32507 Phone: 850-455-4552

Directions from Atlanta: I-85 south, to Montgomery, AL. Take I-65 south to exit 69 to Flomaton / Wallace. Turn Left at AL-113. go 14 miles, turn right at US-29 / US-31. Go 1.1 miles, turn right at US-29 south. Continue to Pensacola, Bear right onto Pace Blvd. Right at Barrancas Ave. Go 1.6 miles Right at Weis Lane. Go 343 feet. Left at Lakewood Road, go 0.2 miles. Arrive at 806 Lakewood Road, Pensacola, FL, 32507

Marina Facilities: Island Cove Marina or Sabine Marina on Pensacola Beach

Reservations: Contact Eric Peters @ 850-455-4552. Slips are \$1.00 per foot per night.

If you choose to stay on Pensacola Beach, recommended Marina is Sabine Marina. \$100 deposit required now to make sure you get a transient slip. Slip cost min of \$30 + taxes up to 30ft boat (\$1/ft + taxes for boats over 30ft). Reservations: Contact Jerry Podogil, Dockmaster, 850-748-3507.

Boat Launching Ramp: Pensacola Marine Complex. Phone: 850-439-1708 (700 South Myrick Street. Pensacola, Florida 32507) From Pace Blvd. go west on Garden Street. / Hwy. 98 – less than ½ mile Left at South Myrick Street – continue a short distance to the ramp. \$5.00 / boat launch fee, and trailer parking at \$5.00 / day.

If you choose to stay on Pensacola Beach, use Shoreline Park Boat Ramp in Gulf Breeze, just north of toll bridge to Pensacola Beach.

Tournament Format: ASWSC Points Matrix. Best two of three days fishing.

Weigh-In: The weigh-in on Thursday & Friday will be on "Where To Next?" anchored in Cove just East of Pensacola Pass. Saturday weigh-in (only Saturday's weigh-in) will be at Island Cove Marina. Weigh-in times to be announced at the Captain's Meeting.

Accommodations: Newly Renovated Ashton Inn & Suites, 910 N. Navy Blvd. 850-455-4561. Contact: Gail Jones and reference the Atlanta Saltwater Sportsman's Club. Room rate is now \$89.00 per for two queen beds. All rooms have kitchenettes. (No space for trailer parking). Reservations need to be made SOON, definitely by May 15, 2011, due to 4th of July, the 100yr anniversary of the Navy, and the July 9th Blue Angels Show.

This map provides you some visual context of where Island Cove Marina "B" and Sabine Marina "C" are relative to each other and the Pensacola Pass. You can choose to moor your boat either location but make reservations now for your Pensacola Beach lodging!

This year, July 4th is a Monday, so this tournament is scheduled at the end of that week. One main reason why the fishing is best 2 days over 3 is to incorporate the summer airshow over Pensacola Beach that the Blue Angels fly on Saturday afternoon, 7/9/11.



Keith Mozena and his crew are staying at a beach house on Pensacola Beach (approx 1-2mi east of the St Rd 399 bridge to Pensacola Beach. Where To Next? will be moored at Sabine Marina ("C" on map above, three photos below) right next to the Pensacola Beach bridge. \$100 deposit required to lock in a transient slip now. Slip charges are \$30/day + taxes up to 30ft. Boat ramp at Shoreline Park is recommended. Truck and Trailer can be stored at Shoreline Park as the park is monitored / guarded.



If you'd like to stay on Pensacola Beach, you need to commit now to be able to get a hotel, condo, or house rented. <u>www.VRBO.com</u> can help you find condos and houses for rent. Of course there are a number of hotels out on the beach but they are filling up quickly.
