Refund Policy:

If you cancel 3 weeks prior to the first day of your child's scheduled camp week, a full refund will be issued to you. If you cancel less than 3 weeks before the start of camp, you will not be eligible for a refund. **All cancellations must be put in writing.** This policy will prevent any chance of an error being made. Cancellation for a family emergency or illness will be handled on a case by case basis.

Length and Setting:

Wilderness Skills Camp runs Monday through Friday and begins promptly at 9:30am.

Children must be signed in and out at the ECEC front desk each day.

Prior to the start of camp, each child will receive an information packet detailing what they can expect and how to prepare for camp.
