

# SPRING SEASON 2014

<b>PRACTICES:</b>	10 <sup>th</sup> -12 <sup>th</sup> Graders – MonFri. 2:30-4:15 PM.
	(9 <sup>th</sup> Graders are allowed if they can arrive on time)
	7 <sup>th</sup> -9 <sup>th</sup> Graders – Tues & Thur. – 6:15-8:15 PM.
	6 <sup>th</sup> Graders & younger – Mon. & Wed. – 6:15-7:30 PM.
	A practice calendar will be distributed. Some exceptions apply.

WHEN: Season starts February 18 and ends May 17.

- **GAMES:** Games will be scheduled with other teams including some tournaments. A game schedule will be distributed. Athletes will be put into groups by the coaches for games Varsity Boys, Varsity Girls, Junior Varsity Boys, Junior Varsity Girls, 9<sup>th</sup>/U, 6<sup>th</sup>/U. Athletes may be on more than one team. A team list will be distributed.
- TEAM COST: \$75, or \$60 for KOPFC Members for the entire season. Two ways to sign up 1) Register online with a credit card at kearnswaterpolo.com or 2) fill out the Registration Form on the other side and pay by check (payable to "KOPFC") and give to Brad. Do not try to pay at the front counter.

USA WATER POLO COST: All players must also be registered with USA Water Polo or US Leagues.

- If you plan to play in the summer/fall <u>AND</u> play at JO's and/or do ODP, you should register as a Gold Member \$95.
- If you plan to play in the summer/fall, but do not plan to go to JO's or do ODP, you should register as a Silver Member \$70.
- If you <u>only</u> plan to play during the Spring Season and not go to Irvine or Albuquerque, you can register as a Bronze Member (aka US Leagues) \$30.
- If you qualify for free or reduced school lunch, the Gold Level Membership is only \$35. See Brad for this registration form and must be done by mail.
- It is best to register with USWP on their website, <u>www.usawaterpolo.org</u>. If you prefer to register by mail, forms are on the website. It is \$5 more if by mail.

**TRAVEL TRIPS:** The team has three optional trips planned this spring. Extra cost involved:

- 1. Duke City Invitational, Albuquerque, NM, April 4-6 15/U and 12/U.
  - 2. Kap 7 Cup, Irvine, CA, April 11-13 Varsity Boys, Varsity Girls. Invitations/info will be passed out early March.
  - 3. Utah Summer Games, Cedar City, UT, April 17-19 Varsity and JV Boys and Varsity and JV Girls. Team will travel by charter bus. Invitations/info will be passed out early March.
- FUNDRAISER: A fundraiser will be held so players can raise money to help pay expenses.

# TRAVEL WAIVER AND ACKNOWLEDGMENT OF RISKS

We understand that buses are generally not provided for travel. Occasionally, buses will be used at an additional charge to the players. Athletes are responsible to find their own way to the away games. If traveling with another student, the following guidelines will apply when private vehicles are used:

- 1. The driver, whether student, coach, or parent, must have a valid driver's license and current automobile insurance.
- 2. Every student being transported must have and use a seat belt.

I understand that my son or daughter may have to travel by private vehicle to Water Polo activities which are not held at the Kearns Oquirrh Park Fitness Center. I release responsibility from Kearns High School, the Kearns Oquirrh Park Fitness Center, and the coaching staff from all liabilities for injuries received by athletes while in route to and from contests and practices.

Furthermore, I (parent) fully understand that participation in this activity has the risk of serious injury, paralysis, or even death. We also understand it is recommended that all athletes consult their physician before participating. With full knowledge of these risks, I choose to participate in this program, and I as his/her parent/guardian give my consent for participation, and I authorize the supervising coach to act in my behalf with his/her best judgment in case of an accident.

### **INSURANCE**

We understand that the Kearns Oquirrh Park Fitness Center, Kearns High School, or Granite District does not carry accident insurance for injuries received during practices or competition. We understand that it is the responsibility of the parent/guardian to provide the primary accident insurance. USA Water Polo does provide secondary accident insurance for approved claims for reimbursement.
