## Association of Government Accountants 2013 Scholarship Guidelines and Eligibility Criteria High School Seniors, Part-Time Study

### DEADLINE

Scholarship applications and required documentation must be received by the close of business **Friday, April 19, 2013**. No incomplete or late applications will be considered.

## TYPE AND ELIGIBILITY FOR SCHOLARSHIPS

The Association of Government Accountants (AGA) is pleased to offer:

Up to one \$1,500 academic scholarship for rising part-time study college freshman

- Must be an AGA member or family member (spouse, child or grandchild) and
- Scholarship must be applied toward part-time undergraduate study in a financial management academic discipline\*

\*This includes disciplines such as accounting, auditing, budgeting, economics, finance, electronic data processing, information resources management, and public administration.

## **CRITERIA FOR AWARD**

The **Academic Scholarships** will be awarded on the basis of the candidate's potential for making a meaningful contribution to public financial management. Academic achievement prior to application is an indication of potential for successful study, but is not the only criteria that will be considered in awarding these scholarships. All candidates must have a minimum GPA of 3.0 on a 4.0 scale.

# LETTERS OF RECOMMENDATION

• All **Academic Scholarship** candidates must include a reference letter from an AGA member and from another professional such as a professor, guidance counselor, employer etc. written on professional letterhead.

\*All reference letters and letters of recommendation should be submitted electronically to <u>awards@agacgfm.org</u> along with your application and essay.

## **REQUIRED ESSAY**

All scholarship candidates must submit an **electronic word document** of their essay and application to **Louise Burnette at <u>awards@agacgfm.org</u>**. The essay cannot be more than two double-spaced pages. Make sure to have your full name on the document and specify what scholarship you are applying for.

• Academic Scholarship candidates: "Why I Want a Career in Government Financial Management" \*If you are a past recipient this essay must be modified from your prior year essay.
