

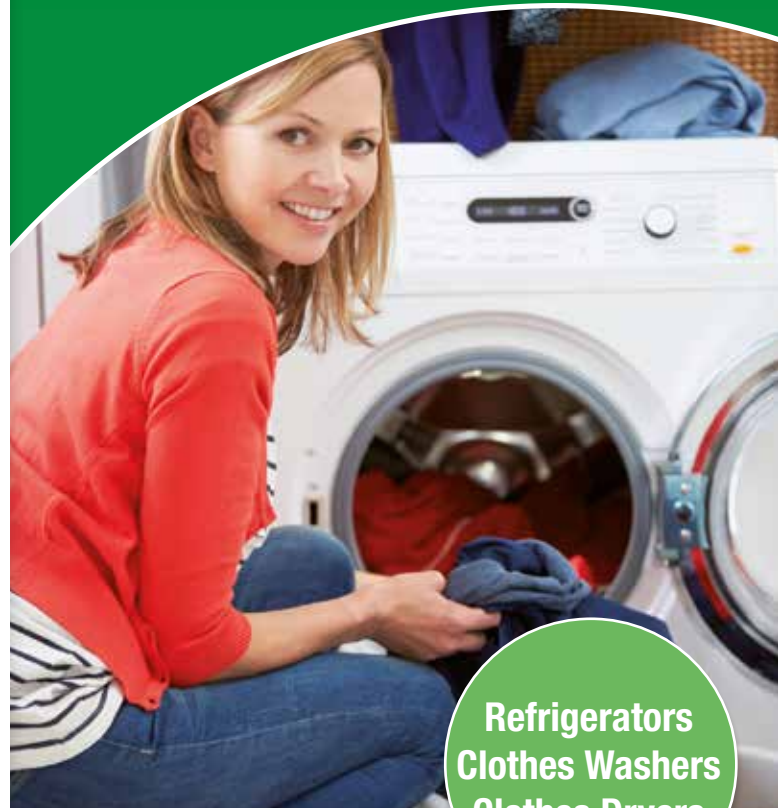

Rebates on Energy-Efficient Appliances

Potomac Edison Rebate Requirements

1. Applicant must be a Maryland residential customer of Potomac Edison.
2. Rebate applications are valid for qualified appliances purchased between January 1, 2016, and December 31, 2017.
3. Rebate application must be submitted within 90 days of purchase and be postmarked by January 7, 2018.
4. Rebate application with valid customer account number must be accompanied by a legible copy of the paid itemized sales receipt showing proof of purchase that includes manufacturer, model number, store name, store location, purchase price and date of purchase.
5. Payment will be issued to the account holder and mailing address on record with the utility.
6. Please allow up to 90 days from the date all required information is received to process your rebate(s).
7. All rebated products must be used at the service address specified on the rebate application.
8. Program procedures, requirements and rebate levels are subject to change or cancellation without notice and are subject to available program funds.
9. Potomac Edison and/or its designees, including program administrators, do not endorse any particular manufacturer or product as part of this program.
10. Customer may receive a rebate of up to \$150 for qualifying refrigerators and up to \$100 for qualifying clothes washers dependent upon the CEE (Consortium for Energy Efficiency) tier rating. Find your model at: www.cee1.org/content/cee-program-resources.
11. Electric clothes dryer must be ENERGY STAR®-certified to qualify for the rebate.
12. By participating in this program, customer agrees to allow the local utility (Potomac Edison) to take ownership of the energy efficiency resource credits associated with the measures generated through this program. Your local utility may at its sole discretion then aggregate your credits with other similarly situated customers and bid the credits into the PJM market through an auction. Any proceeds from any such bids accepted by PJM will be used to offset the costs charged to the utility's customers for compliance with state mandated energy efficiency and/or peak demand requirements.
13. By submitting this Potomac Edison rebate application, you acknowledge and agree to the rebate requirements found on this rebate form.
