We will try again to sponsor an event next year if we get suggestions and help from Members. Networking (Albert Lagore '90 albert.lagore@marquette.edu): This area is considered "fire support" to the modern day networking tool, LinkedIn. We once again asked the graduates who will be entering the IRR (non-pay Individual Ready Reserve) upon commissioning if they would like assistance from A&FA.
