Project Description: Black Infant Health (BIH) is a unique program designed to address African American infant mortality and improve the health status of African American families at-risk for poor birth outcomes. Los Angeles County DPH subcontracts with five (5) community-based organizations to implement the State BIH Program. Subcontractors conduct community education activities to inform community members about African American infant mortality; enroll African American pregnant and postpartum women in the Prenatal Care Outreach Program; and graduate clients from the Social Support & Empowerment intervention.

Community Health Outreach Workers will utilize a street-based outreach strategy to recruit pregnant/parenting women into PCO. Women can enroll while pregnant or parenting a child 15 months old or younger, and can be served until the index child reaches 18 months of age. Throughout PCO, clients receive home visits, positive support, referrals to family supportive services, health education, and invitations to attend activities that celebrate good health in a cultural context.

Along with PCO, some clients will also enroll in SSE. Clients participating in the group intervention must attend six (minimum) out of eight SSE sessions to graduate. SSE sessions are generally held weekly lasting four hours each. Sessions are designed to increase self-awareness and self-esteem via facilitated group discussions, peer support, and personal skills building activities. SSE works because it addresses social factors, provides a framework to teach specific skills, and the group interactions are likely to increase a client's support network.

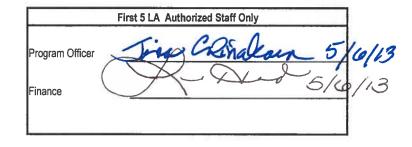

BUDGET NARRATIVE

The Black Infant Health (BIH) Program is funded 35% by local funds from First 5 LA, 35% of Title V State Block Grant Funds and 30% of Title XIX Matching Funds. Title XIX funds are acquired by leveraging local First 5 LA dollars and by participating in the Federal Financial Participation (FFP) Program. DPH is reimbursed for administrative activities associated with assisting individuals eligible for the Medi-Cal Program and assists individuals to access Medi-Cal services. The FFP Program funds are used to supplement BIH Program services.

1. PERSONNEL

<u>Program Manager II (41.20 FTE)</u>: The Program Manager II (PM) provides administrative direction and coordination of and contract management for the Black Infant Health (BIH) Program for the provision of services to high-risk women of childbearing age in African American communities in Los Angeles County. The PMII will have oversight of BIH Program contracted services and ensures that contracted BIH scope of work objectives are implemented and evaluated. Provides technical, programmatic, and fiscal support to five (5) subcontractors to assist their efforts in delivering State Maternal and Child Health BIH interventions (Prenatal Care Outreach and Social Support and Empowerment) in African American communities and to ensure contractual compliance. Prepares internal and external reports for program components and budgets as appropriate and reviews and approves subcontractor invoices. Reviews contractors' budgets/justifications and budget modifications for approval, conducts on-site programmatic monitoring of BH contractors' services and prepares written report of findings, and evaluates and responds to contractors' plans of corrective action. The total amount of funds budgeted for this position is **\$32,912**.

Staff Analyst, Health (41.20 FTE): The Staff Analyst, Health, will provide assistance to the Program Manager II providing oversight for the provision of contract management and monitoring of the BIH Program for the provision of services to high-risk women of childbearing age in African American communities in Los Angeles County. Works with the Program Manger II in the development and evaluation of strategies to reach, identify and inform high risk women eligible for Medi-Cal of prenatal care, and other Medi-Cal services that will benefit them. Ensures that contracted BIH scope of work objectives are implemented and evaluated. Reviews contractors' budgets/justifications and budget modifications for approval, conducts on-site programmatic monitoring of BH contractors' services and prepares written report of findings, and evaluates and responds to contractors' plans of corrective action. Prepares Board packages for submission to Contracts and Grants Division and Board of Supervisors and prepares correspondence for health deputies to keep Board offices informed of BIH Project developments or necessary actions. Prepares the First 5 LA annual budget/justification and budget modifications. The total amount of funds budgeted for this position is **\$36,960**.

2. CONTRACTED SERVICES

<u>Subcontractors</u> - Five community-based agencies will provide BIH Program services to pregnant and parenting African American women throughout Los Angeles County in designated Service Planning Areas (SPAs) and zip codes. Subcontractors will provide health education information about issues

impacting mothers and infants; coordination with providers to ensure timely access to health care services; conducting social support and empowerment classes; and collaboration with other entities to strategize to reduce African American infant mortality.
