Please note that accreditation will not be sent in the post but must be collected in person at media sign on. This will open at 1000hrs on event days only. Accreditation will close 1 hour into each session.

Car park passes for Glasgow and Manchester will be sent via email. Access will NOT be granted by the stewards if parking hasn't been allocated by FACE or the information supplied above (e.g. the registration number) is incorrect.

Access to Hospitality at any of the events will not be granted to anyone with press accreditation. If you need access you will need to be escorted by a member of FACE staff at all times. This must be arranged in advance - please call 0207 490 3000.

Anyone requiring access to the track itself MUST follow the rules below. Anyone not abiding by these rules will be removed. If you have been granted track access you will be given a high-vis bib on accreditation.

1. Have supplied FACE partnership with proof of 3<sup>rd</sup> Party Insurance certificate BEFORE the deadline shown above against each event.

2. Wear the high visibility vest supplied by FACE at all times.

3. Stay on the blue safety apron of the track.

Freelance Journalists and Photographers will only be considered for accreditation if their application is accompanied by a letter of support from an established journal or agency. FACE reserves the right even in this circumstance to restrict accreditation.

Do not forget to include any supportive information (e.g. 3<sup>rd</sup> party liability insurance certificate) along with your application. Please ensure you fill in all information boxes. Failure to do so could result in your application being turned down.
