## IAS 38 – INTANGIBLE ASSETS

---

IAS 38 *Intangible Assets* outlines the accounting requirements for intangible assets that are not dealt with specifically under other IFRSs. Intangible assets are identifiable (i.e. separable or arising from contractual / legal rights) non-monetary assets without physical substance that are recognised if, and only if, certain criteria are met. They are initially measured at cost and thereafter at cost or at revalued amount and are amortised on a systematic basis over their useful lives. The Standard also requires certain disclosures.

IAS 38 was revised in March 2004 and applies to intangible assets acquired in business combinations occurring on or after 31 March 2004, or otherwise to other intangible assets for annual periods beginning on or after 31 March 2004.
