In accordance with his Notice of Motion, Councillor J J McPeake proposed:

"That in the light of the anticipated costs of Local Government reform, that this Council notes with concern the failure of the DoE Minister Alex Attwood to submit a business case to the Assembly Executive seeking financial assistance for Local Government Review of Public Administration and further calls on Minister Attwood to work in partnership and to support Local Government in the submission of an agreed joint business case that will allow for the successful completion of Council reform."

The motion was seconded by **Councillor P J Bateson**.

- In support of his motion, Councillor McPeake said that the PricewaterhouseCoopers report on the RPA exercise had estimated that local government reorganisation would require an upfront investment of approximately £120m and noted that, although it was an Assembly led initiative, it now looked like the costs of reorganisation would have to be met by ratepayers. He said that, although the Minister had previously indicated that he was not going to make a bid for funding to progress the review, he understood that the Minister had put in a bid in the amount of £2.3m to the June public expenditure monitoring round. In his opinion, this was a tentative first step but welcome nonetheless.
- 16.2 **Councillor J Campbell** in response said that he was confused by the Motion's reference to "financial assistance" as he understood that the Department of the Environment were fully supportive of the Review and on that basis he thought that it would not have been unreasonable for all the costs to have been met by the Department. He went on to say that he was unhappy with the way that the Motion appeared to make the Minister personally the scrapegoat for the shortcomings of the nine year RPA process and suggested that a more appropriate Motion might seek to empower the present Minister to deliver the necessary funding.

Councillor Campbell proposed an Amendment to the Motion as follows:

Amendment

"That in light of the anticipated costs of Local Government Council reform that this Council notes with concern the lack of agreement on funding for this proposal and further calls on the Minister of the Environment, Alex Attwood to ascertain full costs of RPA and furthermore demands that the full costs are met by Central Government."

- 16.3 **Councillor Miss K A Lagan** seconded the amendment
- 16.4 **Councillor G C Shiels** stated that, although he was not in favour of the Review of Public Administration, he would support the amendment.
- 16.5 The Chairperson **Councillor McLean** stated that his party grouping would support the amendment.

16.6 On a vote being taken on the Amendment, 7 Members voted for, 8 Members voted against. Voting being by show of hands. The Chairperson declared the Amendment lost.

Substantive Motion

- On a vote being taken on the Notice of Motion, 8 Members voted for, 7 Members voted against, voting being by show of hands. The Chairperson declared the motion carried.
- 16.8 Councillor Campbell remarked that he felt that, in failing to adopt the proposed Amendment, Magherafelt District Council would be the only council in Northern Ireland to have failed to do so.
