If the Expo can not take place due to civil disobedience or national emergency, the ASC will attempt to work with every exhibitor to refund a portion of their booth fee. Furthermore, the ASC will have no other obligation of liability to exhibitor.

The Augusta Sports Council will take responsible precautions to safeguard exhibitor's property. However, the ASC will not be liable for loss or damage to property and merchandise from theft, fire, weather, accident, or any other cause. Exhibitor agrees to indemnify, protect, defend, save and hold harmless the Augusta Sports Council, USA Cycling, City of Augusta, Fort Gordon and U.S. Army Corps of Engineers, their directors, organizers, agents, representatives, or employees from all claims, demands, damages and liability of any kind by person or persons on account of damages to property or the leased premises arising out of the use of exhibitor's leased premises by the exhibitor, or the negligence or willful misconduct of exhibitor or its agents employees or invitees or a breach of the agreement by exhibitor or its agents employees or invitees. The exhibitor, on signing the Expo Application, expressly releases the aforementioned from all claims for loss, damage or injury.

Additionally, the Exhibitor shall maintain Commercial General Liability Insurance to include premises/operations, independent contractors, completed operations and blanket contractual liability including broad form property damage coverage in the amount of \$1,000,000 per occurrence and \$2,000,000 aggregate limit, naming the Greater Augusta Sports Council as the additional insured. Exhibitor will provide a certificate of insurance indicating the placement of such coverage by June 15, 2012.
