Through those years Karen has diligently acted as a professional and personal helper and mentor to the residents, helping AMIB achieve its mission to provide them with life-long care. She goes above and beyond to advocate, research and comfort those in need and to ensure that their days are filled with meaningful activities that take their abilities and preferences into consideration.

Residents who know Karen describe her as caring, loving, fair, understanding, patient and a true friend. The staff considers her a truly genuine, honest, devoted role model with a knack for maintaining a homelike environment for the residents.

All eight residents have had 23 years of wonderful memories with Karen. One tells of how, when he was diagnosed with kidney renal failure, Karen spent long hours in the library researching his nutritional needs, creating special menus and learning more about his illness. He is grateful that he never had to go through dialysis alone, and that Karen was always there with him.

Karen is more than willing to lend a helping hand to a new management member or to assist a house that is short-staffed. With all her responsibilities, she continues to demonstrate her competency in multi-tasking, meeting deadlines and keeping things running smoothly.

Karen has been with the agency for two-thirds of its existence, and her commitment to keep her feet on the ground and her dedication to our residents has inspired other professionals to consider working in this field.

A Bequest to the AMIB Endowment Fund

A tax-deductible bequest in your will is an excellent way to become a member of The Legacy Society and make a significant gift that may not be possible during a lifetime. If you have an up-to-date will and want to include a provision to provide permanent assurance of the future of AMIB residents, ask your attorney to add an amendment, known as a codicil. Suggested wording for a will or codicil could be:

*"I give and bequeath to the **AMIB Endowment Fund**, 909 Cedar Bridge Avenue, Brick, New Jersey 08723-4259, the sum of \$_____ (or _____ percent of my estate) and/or the following property _____."*

Some other opportunities to make a planned gift to AMIB's Endowment Fund and become a member of The Legacy Society include: creating a charitable remainder trust; giving a paid-up insurance policy; and arranging for a gift of appreciated long-term capital gain securities or real estate.

Mary Carson's Legacy to AMIB

We welcome Mary Carson as the newest member to join The Legacy Society. To help ensure the financial future of AMIB and its residents, Mary recently provided for a significant bequest naming the AMIB Endowment Fund in her will. She is the mother of five children: Cecilia; Mark; Louise; Bayville home resident Mary Carol; and AMIB president, Ken Carson, Jr. She is the widow of Kenneth J. Carson, Sr., who served on AMIB's board for many years and after whom AMIB's long-term care home in Lacey Township is named.

Mary Carson's second child, Mary Carol, was born on October 5, 1948, in Cleveland, Ohio. A premature baby weighing only 2 pounds, 3 ounces, she was not expected to live. Her twin brother, Patrick, had died eight hours after birth.

Four months later, when the Carson family moved to New Jersey, they discovered that, because Mary Carol had been given too much oxygen at birth, she was blind. However, it was not until she reached the age of 10 that her parents discovered their blind daughter was also retarded.

Mary Carol stayed home with her parents until she was 14 when she entered the Woodbridge State School as one of 50 residential students. The school offered programs for children who were either blind or who had a wide variety of other developmental disabilities.

One day when she was visiting Woodbridge, Mary met Polly Wilson. She learned that Polly's daughter had the same conditions as Mary Carol. Polly and her husband, Al, were trying to set up a group home with a small number of children who would be able to receive individual attention in a homelike setting.

Polly eventually persuaded Mary to enroll her daughter as one of eight residents of the second AMIB home in Bayville. Mary and Ken became so delighted with the way Mary Carol settled

into her new home and the people who took care of her, that they decided to do all they could to help the fledgling organization.

Ken agreed to work on fundraising. He also created a newsletter for AMIB. Mary, too, helped to raise funds. She and her friend, Gloria Smith, started a regular bridge party, which raised between \$200 and \$300 each year.

Mary was also certified in Braille and transcribed books for the blind. Among the books she most fondly remembers transcribing were Winnie the Pooh and Christopher Columbus. Mary estimates that over a 30-year period she transcribed over 25,000 pages. She also taught Braille at various locations including Ocean County College.

Over the years, Mary and her husband were instrumental in the growth and development of AMIB. Ken served on the board of directors for many years, several as vice president. In 1980, after 35 years as executive vice president of the Inmont Corporation in Clifton, he retired and was able to devote even more time to AMIB. He died in December 2002.

Mary Carson says that AMIB has been a wonderful experience for her daughter. As a resident of the Bayville home where she receives one-on-one attention, her daughter has blossomed.

Before coming to Bayville, Mary Carol was quiet and regressed. She didn't even know what a telephone was and had never used one.

At the group home she enjoys talking on the phone, is sociable, happy, lives independently, does many things for herself, and enjoys the companionship of the other Bayville residents.

Mary Carson is grateful to the people of AMIB for all they have done for her daughter. She hopes that others will follow her example by becoming members of The Legacy Society and helping AMIB provide special care for blind, developmentally disabled children like Mary Carol.

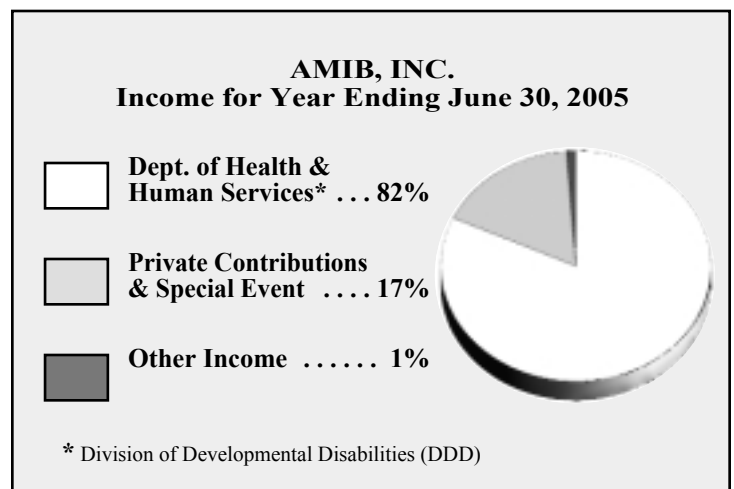
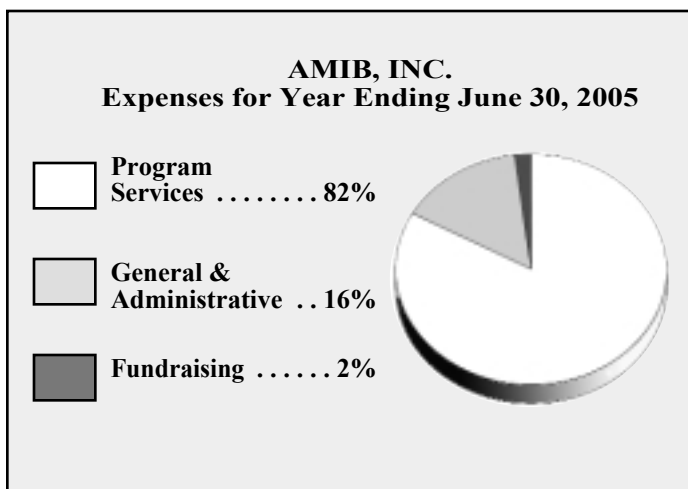
- ❖ Completed Phase II of the Vision of Independence Capital Campaign.
- ❖ Met the Harry and Jeanette Weinberg Foundation \$150,000 Challenge.
- ❖ August 22, 2005, David R. Bixel, AMIB Endowment Fund President and Chairman of the Vision of Independence Capital Campaign, died in a tragic automobile accident.
- ❖ From interest that will be earned on David Bixel's \$41,000 Legacy Gift to the AMIB Endowment Fund, the AMIB Board established the Bixel Respite Services Fund to provide respite for families with blind, developmentally disabled children.
- ❖ AMIB Board created a five-year plan — 2006 through 2011.
- ❖ In fulfillment of Capital Campaign, AMIB completed the sale of the Toms River Group home.
- ❖ On the death of David Mathey in February 2005, AMIB became a beneficiary of the David Mathey Charitable Remainder Unitrust. Over the next 15 years, distributions to AMIB from the trust are expected to reach well over \$1 million.
- ❖ AMIB staff members, Roseanne Fetzer and Sue Smykla, completed over 20 years of service to AMIB; Karen Kerrigan received the 2005 NJACP Leadership Award.
