We request the following changes to Condition 3:

"Except as may otherwise be agreed in writing by the Waste Planning Authority, site operations and any associated activities shall only be carried out between the hours of 07:00 and 18:00 Mondays to Fridays and 07:00 and 13:00 on Saturdays. During the hours of 13:00hrs and 16:00hrs on Saturday's deliveries only of non-hazardous waste material are permitted but there shall be no processing of waste materials or any other associated activities. In addition up to 20 HGVs may deposit material within the waste recycling building between 0800hrs and 1600hrs on Sundays and Bank Holidays, but there shall be no processing of waste materials or any other associated activities."

Condition 13 as follows:"The development hereby permitted shall cease no later than 30th September 2030 (twenty and thirty) by which time the recycling building shall be dismantled, foundations and hard standings removed and the site shall be restore or reinstated in accordance with the conditions attached to planning permission KE/89/0791."
