CIGARETTES: SMOKING DURING PREGNANCY

ISSUE

The effects of smoking cigarettes during pregnancy include causing the baby to: (1-2)

- Be born too soon (premature).
- Be born too small (low birth weight).
- Die during pregnancy (fetal death) or die before the baby turns one year old (infant death).

Cigarette smoking is the #1 preventable cause of death for adults.



Pregnant women who smoke cigarettes are also more likely to experience a miscarriage or have a baby with birth defects. ⁽¹⁻²⁾

FINDINGS

Cigarette smoking during pregnancy has decreased over the past decade, but remains high among pregnant Thurston County women. Thurston County women have *significantly* higher rates of cigarette smoking during pregnancy compared to Washington State women.


- In 2010, 13% of births to Thurston County women involved cigarette smoking during pregnancy (87% of did not involve smoking during pregnancy). ⁽⁴⁾
- Each year on average 418 babies are born to Thurston County women who smoked cigarettes during pregnancy (based on 2006-2010 data, most recent five years). ⁽⁴⁾

DETAILED DATA

In general, births to women who live in southern areas of Thurston County are more likely to involve cigarette smoking during pregnancy. ⁽⁴⁾



The 98589 zip code (Tenino) has the highest percent of births to women who smoked cigarettes during pregnancy. The 98516 zip code (Olympia-Lacey) the lowest percent.⁽⁴⁾





- Thurston County women in every age group are more likely than women across Washington State to smoke cigarettes during pregnancy.
 - Births to Thurston County adolescent women and women in their twenties are more likely to involve smoking during pregnancy when compared to other age groups (Age 10-19 = 27% smoking, 73% no smoking; Age 20-29 = 17% smoking, 83% no smoking). ⁽⁴⁾



 Births to American Indian & Alaskan Native women are more likely to involve cigarette smoking during pregnancy (23% smoking, 77% no smoking). ⁽⁴⁾
