

#### Statute of a Foundation:

# National Section of the International Conneil of Organizations for Folklore Festivals and Folk Art (CIOFF)

The Foundation is incorporated based on an act of donation by Emil Boyanov Pavlov, EGN: 5912861447, dated 11.12.2001.

### 1. General Provisions

Art.1. Name of the Foundation: National Section of International Council of Organizations for Folkfore Festivals and Folk Art (CIOFF).

Art.2 The Foundation is a non-profit legal entity. It acquired this capacity upon its entering in the Register of Sofia City Court.

Art.3 The seat of the Foundation is: Republic of Bulgaria, Sofia, Triaditsa area, 1 Bulgaria sq., National Palace of Culture, floor 14, office No 12-15.

Art.4 The Foundation is incorporated for an indefinite period of time.

Art.5 The Foundation is incorporated for the execution of socially useful activities.

#### II. Aims and Activities of the Foundation

Art.6 (1) The Foundation pursues a common goal to develop the cultural exchange between peoples and to popularize the Bulgarian folklore in Bulgaria and abroad.

- (2) The Foundation has the following specific aims:
- Country's representation in the International Council of Organizations for Folklore Festivals and Folk Art (CIOFF);
- Assistance to the organization and holding international folk festivals in the country and abroad;
- Collaboration with a view to closer cooperation and mutual support with other foundations and organizations with similar aims in the country and abroad.
- 4. Popularization of the Bulgarian dance folklore heritage.
- 5. Enrichment of the knowledge about the folklore heritage of peoples.

 Fostering and creating conditions for active cultural exchange between institutes and bodies of the member countries in the folklore festivals.

Art.7 In line with its aims the Foundation shall:

- Represent before any physical/legal entities and organizations, bodies of the state or local power the International Council of Organizations for Folklore Festivals and Folk Art (CIOFF).
- Assist the organization and holding of international folklore festivals in the country and abroad.
- Strive for closer cooperation and mutual support with other foundations and organizations with similar aims in the country and abroad.
- 4. Synchronize the activities of state bodies and other legal and physical entities from various countries with a view to holding festivals and biennales with a view to intensifying the cultural exchange between peoples.
- Support Bulgarian and foreign folklore assembles by assisting their participation in international folklore festivals.
- 6. Organize schools, seminars and courses for popularizing the Bulgarian folklore dancing arr.
- Invite foreign figures and assembles and to finance their stay in the country aimed at getting familiar with Bulgarian folklore traditions.

#### ill Property

Art.8 (1) The property of the Foundation is collected from the following sources:

- · Initial donation from the Founder at the time of incorporating the Foundation.
- Donations and inheritance from Bulgarian and foreign physical and legal entities and organizations.
- · Proceedings from real estate owned by the Foundation.
- Proceedings and income from other sources not related to commercial activities.
- (2) The disposal with the funds and other property of the Foundation is performed by the management bodies of the Foundation in strict compliance with its aims and the provisions herein.
- (3) The following may be subject to donations or inheritance: real and movable property, real rights, money, currency, stocks, stock options, authorship and other non-property rights.
- (4) The Foundation may refuse to accept donations or inheritance due to inappropriate conditions or jeopardizing its aims and the provisions of this Statute.
- (5) The Foundation may incorporate and participate in the incorporation of other non-profit organizations or companies.

# IV. Management and Representation

Art.9 (1) The chairman of the Foundation shall be its founder or a person assigned by the latter. He shall represent the Foundation before any state body, physical/legal entity or organization.

- (2) By decision of the founder the Foundation may create other bodies of management and control.
- (3) The chairman has the right to delegate to other persons certain activities on behalf of the Foundation.
- (4) The founder has the right to take decisions:
  - 1. To establish the Foundation,
  - 2. To change the seat or aims of the Foundation,
  - 3. To amend or supplement its Statute:
  - 4. To plan, organize and control the performance of employees at the Foundation;
  - 5. To decide to terminate it.

# V. Termination and Liquidation

Art.10. (1) The Foundation shall be terminated by the relevant court if its aims have become unattainable or in case of violations to the law or the state and social order.

(2) Upon termination of the Foundation its property shall become the property of the state, which is responsible for responsibilities of the Foundation to third persons and equal to the received property.

#### VI. Concluding Provisions

Art.11 This Stature of the Foundation is approved on 11.12.2001 by the founder of the Foundation: Emil Boyanov Paylov and it represents an integral part of the Act of Donation.
