1. AUTHORITY

The event will be conducted under the International Sporting Code of FIA, the National Competition Rules and Race Meeting Standing Regulations of the Confederation of Australian Motorsport Limited (CAMS), the 2012 Victorian State Circuit Racing Championships Series Regulations, these General Supplementary Regulations and any Further Regulations or instructions that may be issued.

The Stewards of the meeting will be: Ken Innes Irons, Erik Rubens & Colin Hardinge The Chief Scrutineer of the meeting will be advised in the Further Regulations.

4. EVENT DESCRIPTION

The event shall be held over three days. Friday 15th June 2012 will be a Private Practice activity. Saturday 16th & Sunday 17th June 2012 will be a State Championship Race Meeting. All three days activities will be conducted at Sandown International Raceway and cars will circulate in an anticlockwise direction of the 3.1 km National Circuit.

5. CATEGORIES

Qualifying / Racing will be provided for the following categories: Formula Vee, Formula Ford (1600 & Duratec), MG/British, Sports Cars, HQ Holden, Improved Production inc BMW E30, Sports Sedans, 944 Challenge and Supersports.

6. ENTRIES 2/2

Entries will open on Monday 16th April 2011 and close on Monday 4^h June 2012 except for the Friday practice activity for which entries close 10:00 am Friday 15th June 2012. The entry fee for will be \$160.00 GST inc. for the Friday practice activity, and for Saturday/Sunday will be \$370.00 GST incl. for entries received up to **Wednesday 16th May 2012**, and \$400.00 GST inc. thereafter up until the closing date. The maximum number of entries accepted will be 356.

A surcharge of \$110 GST inc.applies to any entry which nominates for more than one category with the same driver. In these cases the driver must indicate on the entry form his/hers first and second choice of which category they would like to run. A separate full entry fee is payable if the cross entry is for the same vehicle but with a different driver. A separate full entry fee is also payable if a driver enters more than one category with a different vehicle. All drivers must be current financial members of clubs affiliated with CAMS and hold a PCC, CC, PC, NC, ICC or other type of license as approved for the racing events.

Preferred car numbers are to be requested on the entry forms. These will be allocated on a first come first served basis or if the categories have their own pre allocated numbers, then they will be used.

6. GARAGE HIRE

There are a number of garages for hire. The pit lane garages are all doubles or triples and when you hire a garage you get a space measuring 8.5 meters deep and <u>one</u> car width across. Whether you wish to share the garage, with one car behind the other, is up to you. There are also new, single garages along the rear fence of the paddock area. No deposit is required but if the garage is not left in a clean and tidy state at the conclusion of the meeting, the organising committee reserves the right to charge the competitor a fee to do so. Garages will be allocated on a first come first served basis. The garage form has details.

7. SERIES REGULATIONS

8. GENERAL

- The organisers reserve the right to refuse any entry without assigning any reason thereto, in accordance with the provisions of NCR 83.
- Protests must be in accordance with Part XII of the NCR's.
- Insurance has been affected by the promoter in accordance with Appendix I of the CAMS Manual.
- The promoter reserves the right to cancel. Postpone or abandon the event in accordance with NCR59.
- Vehicles must be adequately muffled to comply with noise restrictions.
- Driver apparel shall be in accordance with Schedule D of the 2012 CAMS Manual of Motor Sport.
- Scrutiny on Saturday & Sunday shall commence at 7:30am, with track activity beginning at 9:00am

9. TARGETED SCRUTINY

Targeted Scrutiny procedures will apply at all three days of this meeting to cars entered in races. Competitors must complete the audit history on the rear page of the entry form. The audit history will be used to determine if an examination is required at the event by the Scrutineers. If the vehicle is not due for examination, the scrutineers still have the right to conduct random audits during the event. Vehicle classes and eligibility can be found in the 2012 Victorian State Circuit Racing Championships Series Regulations.

10. ANTI DOPING POLICY

During any event, consumption of alcoholic beverages in the paddock, pits or any other portion of the competition venue under the control of the officials is expressly forbidden until all practice or competition activity is concluded for each day. Any driver or crew member who is found to be affected by alcohol on the day of the event or practice therefore shall not be permitted to participate. Refer NCR 145A of the Current CAMS Manual. In addition, the persons concerned will be subject to the Articles of the Standard Operating Procedure for Alcohol Testing and CAMS Anti-Doping Policy. Competitors, crews or officials may be randomly tested for alcohol by a CAMS Accredited Testing Official (CATO) or other drugs at any time during the event(s).

The CAMS Drugs in Sport Policy, as appears in the CAMS Manual of Motor Sport and as amended from time to time, is recognised as an integral component of the NCR and is duly authorised as such.

In any areas where the National Competition Rules and the Drugs in Sport Policy conflict, the Drugs in Sport Policy will take precedence.
